### **Report from ACRL 10th National Conference**

Members of CLS know the benefits of working in a college library. At the ACRL National Conference a panel of college library directors sought to entice their research library colleagues into considering the college library directorship as a new career path. The program, "The Grass IS Greener at College Libraries: Making the Move from Mid-Level Research Library Manager to College Library Director," was sponsored by the CLS Leadership Committee. Steven Bell, Library Director at Philadelphia University, moderated the session. The panelists were Susan Richards, University Librarian at Lawrence University, and Susan Swords Steffen, Library Director at Elmhurst College. Barbara Brown, University Librarian at Washington and Lee University, helped to plan the session but was unable to participate as a panelist.

Using an interview style forum, the moderator asked the panelists to respond to a series of questions designed to help the attendees gain insight into the rewards of directing a college library. After each panelist discussed how and why they migrated from their mid-level managerial positions in large university research libraries, the panelists advised attendees on such topics as adapting to the college culture, reporting to academic officers, developing a broad skill set, and good questions to ask at job interviews. A core theme of all the discussion was that the college library was a less bureaucratic setting where directors could establish warm relationships with faculty and students.

The panelists then engaged in a 45 minute question and answer session during which they were queried about their educational backgrounds, how they make decisions, staff management issues, how they assessed the financial health of the institution before taking the directorship, special activities that get them involved with students, and whether to go with a public or private college. Larry Hardesty and Damon Hickey, two veteran directors, were on hand to provide additional advice to attendees, and Hardesty described the College Library Directors Mentor Program. Based on the interest and enthusiasm shown by the attendees, it appears that university libraries will continue in the role of incubator for future college library directors.

**At Last--the Price of the CLS Friday Night Feast Explained!**

**Research for College Librarianship Committee Helps ACRL Advance Into The E-Publication Arena**

In 1997, inspired by an idea from Michael McLane to produce a directory of publications for college librarians and to include information such as whether editors would invite discussion about potential article ideas, the College Libraries Section's Research for College Librarianship Committee produced the ACRL print publication, *InPrint: Publication Opportunities for College Librarians*. It was edited by Lynn W. Livingston and compiled by Alice Harrison Bahr and Michael J. McLane.

The print publication sold out almost immediately. When the time came to revise it, the Committee decided to explore creating a continuously updated Web version. The end result is that the College Libraries Section will have contributed the first title to ACRL's new e-publications effort. ACRL launched the Web version of *InPrint* in early January 2001.

It took almost a year to develop and refine the databases that comprise the project, the Web interfaces linked to the databases that allow hassle-free data entry, and to obtain, verify, and enter information gathered from editors. Then, it took ACRL several months to create a Web interface for the publication's users. It will take another six months or so to develop procedures for transferring the working database used for continuous updates to an ACRL server.

One benefit of *InPrint* is that it allows great flexibility in reviewing and selecting journals in which to publish. Not only do the descriptions of titles include e-mail links to editors, but a searcher can specify that s/he wants only titles that are refereed, that have an acceptance rate of better than 50 percent, that require fewer than 20 pages, and that have editors who will respond to writers in less than two months.

*InPrint: Publishing Opportunities for College Librarians* is available at <http://acrl.telusys.net/epubs/> for \$35 (\$25 for ACRL members). The cost includes access to the data for two years which will be updated by RCLC members every six months. Under the leadership of editor Alice Harrison Bahr, contributors to the first Web version include Anne C. Ciliberti, Eric A. Kidwell, Michael J. McLane, Christopher Millson-Martula, and Bill Nelson.

*InPrint* is but one of a number of activities that the RCLC sponsors to promote research and publication in college librarianship. The Committee co-sponsored with the CLS Clip Notes Committee, *1-800-Publish: Helplines for Advancing Yourself and the Profession*, a discussion highlighting three research and publishing mentoring programs within ACRL. At ACRL national conferences, the Committee typically hosts a roundtable discussion where participants share their experiences and knowledge. The topic for the Denver conference was *In the Pits and Over the Peaks: On the Road to Publication*. ### CLS Committee Updates

#### ***Clip Notes Committee met on January 13th, 2001.***

Jody Caldwell reported on the progress of the Appropriate Use CLIP. The compilers plan to have materials to ACRL by the ALA Annual Conference. Jamie Hastreiter reported that the Travel Policies CLIP has been seriously delayed. Lewis Miller reported that he received three CLIP inquiries over the summer: one on assessment tools for information literacy, one on plagiarism, and one on another information literacy topic. Jody suggested that making contacts through the state ACRL chapters might be an

effective way to reach working librarians. ACRL is proceeding with the electronic publications program. There was a discussion, but no final decision, as to whether this is appropriate for CLIP Notes.

***Communications Committee met on January 13th, 2001.***

The group examined a report filed by John West about the web site. He posed the question of how long various types of requested information should be kept at the site. It was decided that we would hold a decision on that question until summer, giving Melinda a chance to talk to John in detail about the matter. Terry Ballard reported the results of checking the newsletters web site for errors. As some sites maintained newsletters whose most current issues were in 1998, the group decided that one year should be the standard for currency. If a link with no content is still lacking content before the next conference, the link will be removed. No links will be provided for newsletters that must be downloaded to file. Only web-based newsletters will be linked. Link checking for the summer meeting will be performed by Wayne Bivens-Tatum. Catherine Lee volunteered to continue hosting an imaged version of the *CLS Newsletter*, and sending an HTML version to John. John suggested that we consider having only one version of the newsletter. For now, the Committee agreed to continue with both an html and image version of the Newsletter. Catherine will provide both formats to John.

***Leadership Committee met on Monday, January 15th, 2001.***

Rick AmRhein will coordinate, and Chris Millson-Martula and Tara Fulton will assist, in developing an article for a non-library academic audience on successful searches for library directors. The target audience will be college administrators, not librarians. The topic is timely since there seems to be a shortage of candidates, especially for management positions.

**Mentoring Program.** 130 new directors and about 80 mentors in almost every state have participated in the College Library Directors Mentor Program since Larry Hardesty began the program 9 years ago.

**ACRL Strategic Plan.** The Committee reviewed the ACRL Strategic Plan and agreed that its work is most closely related to goals 1.1, 1.3, 2.3, and 4.1.

***Research for College Librarianship Committee met on January 14th, 2001.***

Chair Chris Millson-Martula submitted a proposal for a roundtable discussion at the ACRL Conference entitled *In the Pits and Over the Peaks: On The Road To Publication*. Alice Bahr brought the Committee up to date on the progress to produce the new, improved, revised and electronic second edition of ***InPrint: Publishing Opportunities for College Librarians***. Currently, there are 116 entries for the updated edition: 34 are new while 7 from the first edition have been dropped. Coverage has been expanded to include related journals of interest to college librarians. A process for updating the database was reviewed. It was agreed that virtual committee members who could help with the work of updating the database would be beneficial even if they could not attend meetings. Alice will remain Editor-in-Chief. Committee members who work on updating and maintaining the database information will be listed as Assistant Editors of ***InPrint***. Alice reported on a prospective ALA Research Database which would list research projects and people interested in participating. The project will be reviewed further by the Committee. The meeting adjourned at 9:00 and was followed by an excellent program sponsored by the Committee: ***1-800-PUBLISH: Helplines for Advancing Yourself and the Profession***.

***Membership Committee met on January 15th, 2001.***

The Committee will ask ACRL to provide data about CLS members from the recent ACRL member survey.  
**Recruiting Members.** Susan Richards will get a list of those subscribed to COLLIB-L and the New

Directors' listserv. Catherine Lee will get the list of CLS members from the ACRL office. Melinda Dermody will get a list of those attending the three CLS discussion groups. Albie Johnson will then cross-check these lists and produce a final list of individuals who have shown interest in CLS in some way, but do not belong to the section. Our goal is to have this completed by June. Melinda will send a message to the COLLIB-L listserv over the next few weeks outlining the benefits of CLS membership and pointing out that section membership is free with ACRL membership. Susan will investigate purchasing stickers for our conference badges that say "CLS." We hope to have these for the annual conference.

### ***Standards Committee met on January 13th, 2001.***

The Committee reviewed and discussed the Committee charge. Rebecca Bostian suggested changes to the charge. Bill Nelson will present the revision to the Executive Committee. The revised charge is as follows:

**To promote the implementation of the *Standards for College Libraries*, 2000 edition; identify and track new concerns that arise regarding standards; investigate mechanisms for evaluating the standards for continuous improvement; and serve as the group primarily responsible for determining the need for additional standards and for revising the standards once the time for such revision has arrived.**

The Committee discussed the ACRL Strategic Plan. Mickey Zemon indicated that the committees need to report on how their work is aligned with the ACRL goals. The Committee reviewed the ACRL goals and agreed that its work is most closely related to goals 1.5, 2.1, 2.2, and 2.3. Bill will write a draft report of what the Committee has done or plans to do related to these goals.

### **Proposed Changes to Bylaws Modifications are underlined. Deletions are in brackets.**

#### **Article IV. Officers**

Sec. 1. *Officers.* The officers of the Section shall be the immediate past-chair, the immediate past secretary, chair, vice-chair/chair-elect, and a secretary.

Sec. 2. *Terms.* The immediate past-chair, the immediate past secretary, chair, vice-chair/chair-elect and secretary shall serve for one year. {The chair-elect shall serve for one year as vice-chair.} At the expiration of the vice-chair/chair-elect's term, {that term} or upon the occurrence of an earlier vacancy, the vice-chair/chair-elect shall succeed to the office of chair. All officers and members of the Executive Committee begin their terms with the adjournment of the annual conference.

#### **Article VI. Committees**

Sec. 1. *Authorization.* Committees of the Section shall be established by action of the chair after consultation with the Executive Committee. Committees may propose policy, but those recommendations must go to the Executive Committee for approval (except for the policy regarding money, which must go to ACRL). All policies must be in agreement with ALA and ACRL policies.

### **Discussion Group Updates**

***Medium-Sized Academic Libraries Discussion Group met on January 14th, 2001.***

The topic of discussion was Assessment Tools. Approximately 65 attended and a lively discussion ensued. Discussion covered all aspects of assessment including benchmarking as well as qualitative and quantitative aspects of assessment. Attendees shared their experience and opinions. The name of the group was discussed and the synergy of having viewpoints and experiences from both medium sized colleges and universities was pointed out. It was proposed that 'academic' be added to the name of the group to become the Medium-Sized Academic Libraries Discussion Group. Topics suggested for discussion at Annual in order of preference were:

- 1) Linking ACRL Standards for College Libraries to Assessment and Accreditation;
- 2) Fundraising;
- 3) The Strategic Context of Assessment;
- 4) Assessment of Academic Library Webpages;
- 5) Course Management Software: the Library's Role;
- 6) Management of Electronic Resources from an Administrative Perspective.

The tentative meeting time in San Francisco is Monday, June 18th from 2 to 4 p.m. Check the official meeting program for the final time and location. For the meeting time and place of all the CLS Discussion Groups, check the conference program.

In 1991, Hardesty created and remains active in the College Library Directors Mentor program. To date, more than 200 librarians have participated in the program as either first-year directors or mentors. In 1999, he conceived and established the ACRL Excellence in Academic Libraries Award, the first ACRL award to celebrate institutional excellence. Hardesty will receive a cash award of \$3,000 and a citation at a ceremony and reception to be held on Monday, June 18th, during ALA Annual in San Francisco.
