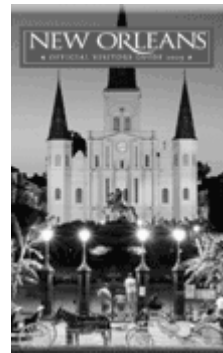
Beyond Katrina: Politics, Race and Law

Lots of interesting accomplishments in our section these past six months.

- Participation with the ACRL environmental scan to identify trends and emerging issues that may affect the future of higher education especially key areas affecting ACRL and its members. Key assumptions about the relevant future for academic and research libraries and libraries are shared on the ACRL webpage. Several that may be of interest to law and political science librarians are: *the need for subject specialized librarians will grow* and *increased "googlization" blurs the line between technology skills and information literacy skills*.
- ACRL funded two LPSS initiatives for members to attend APSA conference and Teaching and Learning conference.
- LPSS Weblogs Discussion Group at ALA Midwinter.
- Political Science Research Competency guidelines review and development of an accompanying rubric during a midwinter meeting.
- Chair attended the 101st American Political Science Association (APSA) Annual meeting & exhibition. Spoke at the Business Meeting of the Undergraduate section to promote the draft of the Research Competency guidelines and encourage their input. Attended the CQ reception and given another opportunity to promote the LPSS Education Task force initiative.
- Four members of LPSS attended the 3rd APSA Teaching and Learning Conference to hold a workshop/focus discussion to improve the Research Competency guidelines and get feedback from teaching faculty about the guidelines rubric's draft. Kathi Fountain shared the feedback received from that workshop with the Education Task Force members.
- Executive Committee agreed to update language in the LPSS manual;
 1. Add the WebMaster to the Executive Committee.
 2. Past Chair duties changed to show--Serves as chair the second year as member of the Review and Planning Committee.
 3. Committee procedures language will include the ALA Policy Manual 4.5 Requirements for Committee Service.

LPSS Midwinter Discussion Group on Blogs

The discussion at Midwinter touched on the many uses of blogs in the academic community. In addition to librarian blogs, we talked about teaching faculty blogs, the use of blogs by students for papers and projects, and the technical and time requirements of putting up a blog. There was also a dialogue about the acceptance of blogs within acad me.

Blogs have many different uses for librarians. A blog can give the academic community information about the library, ranging from public relations announcements to details about a new database. The advantage of relying on blogs instead of email is that the recipients won't be flooded with messages. However, it is a challenge getting patrons to visit the blogs. Users may not think of checking blogs for their information about the library.

Blogs can provide links to other valuable information sources. For instance, many political blogs have links to mass media, such as *The New York Times* and *The Washington Post*, as well as lists of fellow political bloggers. Thus, the blogs can serve as both news and opinion resources. Since most high quality blogs are updated daily, they can be used to follow current events.

Blogs can be an avenue in the classroom to educate students about information literacy. For example, a political opinion blog like www.andrewsullivan.com can be used alongside a traditional news source like *The New York Times* to highlight the differences between opinion and news.

Librarians may be ahead of the curve on this resource. Students may not be aware of blogs or if they do know about them, they are uncertain about their value. However, some students have been using them as sources. For example, there was a reference question from a student who wanted to use military blogs for a paper on the Iraq War. Some creative writing and communication students have been required to create and maintain blogs as part of their class portfolio.

The time required to maintain a blog is a drawback. Keeping blogs updated regularly, like any web resource, is crucial for their success. Librarians responsible for many subject areas would be hard pressed to update them weekly, let alone daily. In addition, there is the concern about investing time in a resource that may not be recognized as useful by colleagues and patrons. Questions were also raised about the technological skills needed to create blogs. However, it was pointed out that there is software that makes that task much easier.

Looking ahead, the participants expressed interest in having further sessions on weblogs. Specifically, a program about weblogs would be a good idea for the national conference in Washington DC in 2007.

LPSS Strategic Plan

At the 2001 Midwinter ALA Meeting, the LPSS Review and Planning Committee began the process of drafting a strategic plan for the Section. The strategic plan would give guidance and purpose to the activities of the section and its committees, as well as help identify future needs of the section. The goal was to present a final draft to the membership at the 2002 meeting.

A first draft was written and sent to Committee members for input. Following a number of revisions, a preliminary draft was sent to the general LPSS membership via e-mail for comment and input. Comments and suggestions were incorporated into the document, with a final draft presented at the LPSS general membership meeting in January 2002. The membership unanimously approved the document.

The Review and Planning Committee, working with other committee chairs, began developing the implementation stage of the strategic plan process at the 2006 Midwinter Meeting of ALA in San Antonio. The proposed strategic plan for 2006-2010 has been aligned with the newly released ACRL strategic plan, "*Charting Our Future: ACRL Strategic Plan 2020*," which is now available at <http://www.ala.org/ala/acrl/aboutacrl/whatisacrl/acrlstratplan/stratplan.htm>

The LPSS five-year strategic plan will be reviewed annually by the Review and Planning Committee. The existing plan expires at the end of June, 2006, and the following new plan is proposed for membership approval. Please send comments to sparker@library.ucla.edu.

MISSION

The Law and Political Science Section (LPSS), a unit of the Association of College and Research Libraries (ACRL), a division of the American Library Association (ALA), is the educational forum and information exchange center for librarians, archivists, and others with interests in all aspects of, or subject expertise in, law or political science collections, libraries, and librarianship.

KEY PRIORITY 1: LEADERSHIP AND INFORMATION FOR POLITICAL SCIENCE AND LAW LIBRARIANS

LPSS is the main source of information pertinent to law and political science libraries, librarians, and librarianship within ACRL and ALA for law and political science libraries, librarians and, librarianship.
