ALA Executive Board Recommends Closing Libraries to Public

The ALA Executive Board released a statement March 17 in support of libraries and library workers during the COVID-19 pandemic.

It reads in part: "The ALA Executive Board unequivocally stands in support of the safety and well-being of library workers and the communities



we serve. To protect library workers and their communities from exposure to COVID-19, we strongly recommend that academic, public, and school library leaders and their trustees and governing bodies evaluate closing libraries to the public and only reopening when guidance from public health officials indicates the risk has significantly subsided. We encourage libraries to ensure that all library workers receive fully paid leave, including health coverage, while libraries are closed."



Both candidates participated in the <u>ALA Presidential and Candidates' Forum</u> that took place at the 2020 ALA Midwinter Meeting in Philadelphia, Pennsylvania.
