## NEW YORK MEETING

Our Section met on Tuesday, July 1, 1952, at the Waldorf Astoria Hotel. Over 100 librarians attended the meeting. The topic "Methods of Stimulating Student Use of the Library for their own Interest and Pleasure" proved to be a very interesting and spirited discussion. Esther Greene, Librarian of Barnard College, served as guest moderator. She suggested the following five ways of stimulating student readings: (1) Make the library attractive by using color, small reading areas, comfortable furniture, and adequate lighting. (2) Give feeling of freedom by using open stacks, having lenient borrowing privileges, and dispensing freely knowledge on the use of the library. (3) Use displays in simple but effective manner. (4) Have an adequate book collection of modern, as well as classic, books. (5) Employ staff members who are readers themselves and who can make an impact on individual students by being able to converse about books.

Other members of the panel were Nellie M. Homes, Cottey Junior College, Nevada, Missouri, who emphasized the fact that suite libraries in dormitories are used primarily for recreational reading, and that short stories, humor, and fiction headed the list in popularity; Francis L. Meals, Colby Junior College, New London, New Hampshire, noted that student library committees recruited from each dormitory developed a real sense of responsibility towards the library and helped to stimulate interest in the student body in general; Barbara M. Smith, Green Mountain Junior College Library, Poultney, Vermont, stressed the importance of cooperation between faculty and library which can be increased by having displays of the personal libraries of faculty and by having annotated lists of faculty favorites in the library. The meeting was a huge success, thanks to our panel members and the interested audience who asked many questions afterwards.

#### MEMBERSHIP

At the July meeting, the membership chairman noted that there was an increase of personal memberships, from 185 in 1951 to 215 in 1952. It is hoped that this year many more junicr college librarians will wish to support our Section, ACRL and ALA. The 1952-53 membership chairman is Lottie M. Skidmore, our vice-chairman. As soon as you receive your membership blanks from ALA in January, be sure to check our Section on the ACRL blank and send it in, along with your ALA blank. You know that with \$6.00 membership in ALA, you may belong to our section and ACRL and receive COLLEGE AND RESEARCH LIBRARIES without any additional charge. So don't forget to renew your membership right after January 1, 1953, and urge other junior college librarians in your state to join also.
