# NEW YEAR - NEW BUSINESS

## Greetings!

Our Junior College Section is meeting as part of the American Library Association conference at the Edgewater Beach Hotel in Chicago. In order that we may have more help on formulating our standards, we have asked Mr. Manning M. Pattillo, Associate Secretary of the Commission on Colleges and Universities of the North Central Association of Colleges and Secondary Schools, to speak to us on the subject: STANDARDS WITH AN ACCENT. Miss Elizabeth Neal of Compton College, our 1955-56 chairman on Junior College Standards, will be there to receive any suggestions. This important session will be held at 8:30, Wednesday evening, February 1, in the Lincoln Room. We hope you can join us.

## THE PHILADELPHIA CONFERENCE

The Junior College Section met in the University Museum, July 5th at 2:30. After a short business meeting conducted by our president, Miss Nellie Homes, Miss Catherine Cardew reported on the work of the Standards Committee. A discussion followed which pointed up the many problems involved in such a statement. "There is a need by many librarians for quantitative measurements. However, a realistic minimum for some libraries represents a regression for others. Such minimum statements, boldly stated and publicized, could actually hamper progress in some colleges."

Miss Cardew then moved as follows:

# HEADQUARTEF

1. If the Standards are publicized in a monograph, they should be prefaced by a clear-cut statement of their purpose and the many types of libraries whose needs must be met. APR 13 1956

AMERIC

2. The standards should be stated in qualitative terms, and references to a bibliography, to published statistics, or to regional standards be made whenever a quantitative example might be desirable.

After further discussion the entire problem was referred back to the Standards Committee. It was further moved that if fundamental changes are to be made in the proposed standards, the revisions should be submitted to the membership for a mail vote.
