## Award Winners

Lois Marriott and Gloria Terwilliger received the two CJCLS/EBSCO awards at ALA in New Orleans.

Lois Marriott's success in strengthening relations between California Community College libraries and the Chancellor's office and California State Legislature inspired her nomination for the Community College Learning Resources Achievement Award for Program Development. Greg Atkins, director of the College of San Mateo stated, "We the librarians, libraries/LRC's, the State Chancellor's Office are in a different and better place than we were when she started."

A leader, advocate, visionary, mentor, consensus-builder and doer, her career has taken her from her B.A. degree in History and English from the University of Iowa, a Master of Arts in Library Science from the University of Wisconsin, Madison and a Master of Arts in Educational Technology from San Diego State University to the Head of Lower Division Library and Coordinator of Circulation Services at San Diego State University and Director of Library Services, Southwestern

While on leave from Southwestern College in 1986-88, she served as Coordinator of Library/LRC Programs in the

### Awards (continued)

Chancellor's Office under an LSCA grant where she made a dramatic impact on the status and support of the 104 California community college libraries and LRC's.

She provided the leadership and program structure for the libraries of the California Community Colleges when a reorganization into a statewide system was forming.

She helped to establish the Chancellor's Library/LRC Advisory Committee as a permanent committee.

She encouraged the development of a data collection instrument acceptable to all 104 libraries.

She coordinated work of a special state budget allocation request which resulted in an additional \$8 million divided among the 104 libraries.

Her work led the way to establishment of the current full-time position of Library/LRC Coordinator in the Chancellor's Office.

### Terwilliger

The Community College Learning Resources Achievement Award for Leadership was presented to Gloria Terwilliger for her pioneering leadership to emerging learning resource center programs at a critical period in the fantastic growth of community colleges.

Director of Learning Resources for 23 years at Alexandria Campus of Northern Virginia Community College, Gloria Terwilliger holds the Master's Degree in Library Science from Catholic University of America and a doctorate in education from the University of Maryland.

She helped to design and

implement the "integrated systems approach" which became a standard among Learning Resources Centers.

She pioneered numerous innovations, including centralized instructional support services, computer-assisted instruction, intershelving media and developing course-related instruction.

Her consulting services helped improve instructional support in over 30 community college systems in the United States and other countries.

She demonstrated strong commitment to participatory management and staff development among the LRC's on the five-campus Northern Virginia Community College District.

She incorporated her love for education and the arts into her career and was selected in 1985 for a Fulbright Study Seminar in India to explore their literary traditions.

A leader, pioneer, visionary, mentor, doer, writer, innovator, consultant and humanist, her publications and presentations frequently charted the future for two-year college learning resources programs.

## Connecting Your Campus to the Internet

The National Science Foundation provides grants to colleges for funds for sharing costs of hardware and communication services to connect to the Internet. "Grants for Research and Education in Science and Engineering; an Application Guide" (GRESE), NSF 90-77, August 1990, is the document that provides information and forms needed for the submission of proposals. Proposals may be submitted at any time; however, target dates are set to allow time for consideration by specially assembled review panels which meet periodically. Applicants should allow at least six months for review and processing.

Colleges may also get assistance in writing their proposals from the regional or mid-level network in their area. In some cases the regional network might submit the proposal for the college or for a group of institutions.

## Alternative Gateways to Internet

More librarians are using Internet because it provides electronic access to global information resources as well as easy access to professional colleagues around the nation. Librarians whose colleges do not provide Internet access have asked what alternative gateways are available to them?

If you are in this group, your first option is to inquire if your state makes Internet access available to its teachers. Community college librarians are sometimes allowed to sign up on such a network. For example, TENET in Texas is available at an annual reate of \$25. (800-258-3638) Fourteen cities in Texas offer local dial pools, so in most cases long distance charges are not required. An increasing number of states are providing this service to their K-12 teachers including North Dakota, Virginia, Florida, and California.

Another option is to inquire at a local university to see if you can obtain a low-cost account. This is worth trying, but it may be difficult to find because Internet expenses are going up.

Jim Milles conducted a survey of commercial Internet access providers and reported it to the Public Access Computer System Forum on May 6, 1993. Examples of the costs of two of these services provided in the accompanying chart give you an idea of commercial costs. One of the least expensive network connections would be through the

You can use either an IBM compatible computer or a Macintosh to access Internet. You will also need a 1200 or 2400 baud modem, communication software and an active phone line connection to the modem.

There are many commercial services available that will provide Internet access. forward to the opportunity to enjoy Miami's cosmopolitan atmosphere, the delightful beaches, and the Cuban cuisine. Mary Ann Laun is working hard on the Choice voc tech core bibliography. Kate Hickey is getting together with Jennie Boyarski in Kentucky to edit the results of the survey to create a collections development policies publication for CJCLS.

Our section will be considering a possible name change. Members have noted it does not include the word, "technical"; on the other hand, AACJC has eliminated the word "Junior" in its name. We will also be considering setting up ad hoc committees. Wanda Johnston did a study on possibilities and considerations for mentoring programs for new LRC directors; I have had several letters from new LRC directors asking for various kinds of assistance such as this. I will be forming an ad hoc committee to develop a CJCLS program proposal for the 7th ACRL National Conference, "Continuity and Tradition: The Promise of Confluence" to be held in Pittsburgh, March 29 - April 1, 1995.
