Florida Computer Break-in by Susan Anderson, St. Petersburg Junior College

On January 19, 1994, the College Center for Library Automation (CCLA) in Tallahassee detected a disruption in the LINCC online system that connects all 28 community colleges in Florida. CCLA system's staff traced the problem to a public access terminal at the St. Petersburg campus library of St. Petersburg Junior College.

The problem, in brief, was that a file had been created, utilizing a little known portion of the LINCC program. The users had requested the system to search and save all titles in the system containing the word "the." In a short time, mainframe disk space was at a premium, and response time suffered.

CCLA contacted St. Petersburg Campus Librarian-in-Charge, Joyce Burkhart, who, investigating the suspect terminal, found an onscreen message from the perpetrators which left no doubt that the problem was the result of deliberate tampering. CCLA requested that SPJC make every effort to catch the person(s) responsible. *cont. p. 2*

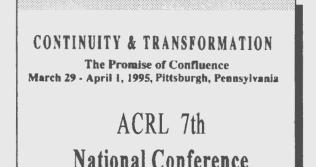

Computer Break-In (cont.)

Burkhart alerted David Zarr, Library AV Supervisor and CCLA liaison, who early on January 20 coordinated a plan with CCLA staff to monitor the SPJC system and inform him at the first sign of system tampering. Several minutes after opening the library at 7:30, CCLA notified Zarr that tampering was in progress. Zarr visually verified the suspects at the terminal, then called campus security. By 7:40 two suspects were in custody.

Before the end of the day, St. Petersburg City Police Department officers had arrested one of the suspects, along with a third accomplice. Both were charged under Florida statute with felony tampering with a computer system and misuse of a computer system and were jailed on \$10,000 bond.

The incident was reported by the local media, picked up by the Associated Press, and was even mentioned nationally by Paul Harvey on his daily radio broadcast.

Miami The Past, The Present & The Future by Douglas K. Lehman Miami-Dade Community College

Miami and The Beaches are truly one of the recent success stories in America. Not yet one hundred years old, Miami and Miami Beach have sprung up from a sand covered barrier island and mangroves to become one of the most populous metropolitan areas in North America. Miami is known as the "capital of the Americas" and Miami Beach has been a tourist's paradise since before the Marx Brothers wreaked havoc in *The Cocoanuts*.

The CJCLS Local Arrangements Committee has put together a Friday night dinner (June 24) with a view that will need to be seen to be believed. Dinner will be at the South Pointe Seafood House at One Washington Avenue inside South Pointe Park on Miami Beach. The park is located at the foot of Washington Avenue adjacent to the historic Government Cut, through which a multitude of cruise ships leave each weekend beginning on Friday nights. Book is Published on Community College LRPs by Wanda K. Johnston, Broome Community College

What is a community college? What are the issues it faces? What is a learning resources program, and how does it fit into the college as a whole? And how is the learning resources program administered?

Administering the Community College Learning Resources Program by Wanda K. Johnston answeres these questions for learning resources faculty, staff, and administrators.

Learning resources programs (LRPs) share a common mission but are unique due to their responsiveness to their parent college's unique characteristics. All LRPs provide the resources and services necessary to serve the informational, learning, and developmental needs of students, faculty, administrators, and broader college community. Nearly always the includes library. LRP media. and telecommunications resources and services. plus occasionally other services. Since each LRP is an integral part of the entire institution, no two are identical.

The LRP administrator is responsible for developing a learning resources program committed to the mission of the community college and to the priorities of his/her own college. He/she is a learning resources generalist, knowledgeable about all aspects of library media, and telecommunications resources and services. He/she orchestrates college priorities, service needs, LRP staff and resources into a successful learning resources program with a vision of the future. With this leadership, the learning resources program is an integral part of the college. Part I of the book reviews the historical perspectives as well as the governance and funding influences affecting the community college movement. Then it desceibes today's community colleges and reviews current issues facing them.

Part II provides an overview of the evolution, scope, and organization of the learning resources program and introduces it within the mission of its parent institution. Components of the most successful community college LRPs nationwide are integrated into a pragmatic model program.

Part III presents a "mini-MBA" in terms of program review and planning, budget, human resources, facilities management, and public relations.

LRPs share a commin mission while remaining unique through their responsiveness to their parent institutions.
