I. AFAS Programming at Annual Conference in San Francisco and at the Black Librarian Conference in Columbus (Biddle)

AFAS Program in San Francisco was quite successful. for "Accessing African American Information Resources" Chair Vivian M. Sykes, SLIS, Univ. of Michigan - Ann Arbor . A panel consisting of a librarian, a professor, a software/CD-ROM vendor and a college student examined bibliographic access to African American information resources. Topics included cataloging and classification, subject headings, indexing and abstracting services, currency of terminology and cultural sensitivity. Panel also address the impact of computerized library catalogs, cooperative collection development arrangement, online databases and CD-ROM sources on the availability and accessibility of information on the African-American experience. Speakers: Vivian M. Sykes doctoral student, Univ. of Michigan; Doris Clack, SLIS Florida State Univ,; David Anthony, History Prof., Univ. of California-Santa Cruz; Diedre Sexton, Student, Univ. of California-Santa Cruz; Lillian Castillo-Speed, Co-ordinator Chicano Studies Univ. of California Library-Berkeley; and a representative from Ethnic Newswatch CD-ROM software.
