# Highlights of the Year/Areas of Concern

#### List Major Activities, Accomplishments with Participation (e.g., Library Legislative Day and number of attendees, legislative successes, new strategic plan, trainings, etc.)

Legislative Time in the District - with the heroic efforts of our members and our wonderful lobbyists, we were able to restore \$4.7M to the State Budget. Trainings - we hosted 2 successful pre-conferences at ALA in Anaheim, with a total of 66 attendees. Our Spring Fling Training included 8 events with 292 total registrants, 4 of these events were webinars with 207 attending. Our CA Summer Reading Program pre-conference (in Pasadena) training workshop had 88 attendees.
