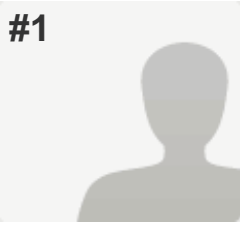

PAGE 9: Highlights of the Year

Q32: List Major Activities, Accomplishments with Participation (e.g.. Library Legislative Day and number of attendees, legislative successes, new strategic plan, trainings, etc.)

4 people went to D.C. in May for Legislative Day. We had one in Indianapolis which was attended by some 65 people. We laid the groundwork for a new 3-year strategic plan, and we had a challenging year in the General Assembly, but thanks to united voices and strong legislative committee and advocates we prevailed (so far). We are implementing a new database management system that will house the online registration, membership activities and website under one system (saving several thousand dollars), and we welcomed Friends of Indiana Libraries as a new division. We are seeing 5000 to 6000 hits per month on our website which is used for a variety of services to members, and we ended the fiscal year some \$65k net. We offered 13 conferences statewide all with good evaluations.

We feel that we need to take a closer look at how the Federation is structured. There are many divisions and some may have run their course. Offering a range of library-related webinars has been slow to take off even though they are quality webinars. In Indiana, a librarian is required to accrue a certain number of LEUs over a 5-year period, and this helps with our attendance at the many conferences that we hold statewide. We count on our members to provide conference topics and speaker ideas on an ongoing basis. This past year ACRL met here in Indianapolis and next year (March 2014) the PLA will be here. We are benefitting from both of those activities.
