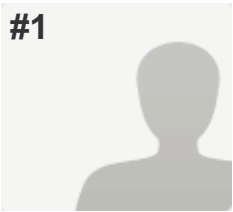

- Implementation of the new Go-to Meeting software has allowed Sections, Roundtables, Committees to meet virtually and more often throughout the year.
- New officers were elected, and a more succinct of nominations has been created. Along with a general push for more nominations for officials and awards.
- Annual Scholarship for Diversity was Awarded.
- The Association connected with Amazon Smile so members may choose to give back in this manner.
- The Association received many vendor sponsorship for the Annual Conference that totaled around \$9,000.
- The Association reviewed different possibilities for a digital repository.
- The information literacy RT held a summer workshop called iTeach2: Enhance and engage. They had 41 attendees.
- The Library marketing and outreach rt held two meet ups and utilized the new go-to meeting software for the online meetup.
- New Members Roundtable continued brunch meetups through out the year.
- The Association began reviewing and editing its current bylaws in hopes of creating an easier document for all.
