Statement of Professional Concerns:

Membership in the ALA has been on the decline in the past two decades. It is time for us to redouble our efforts to stop the decline in our membership. I believe that one of the ALA's greatest strengths lies in the size of its membership.

Inadequate library services in underserved communities remain a critical challenge for us. In my view, it is very important that we pay particular attention to the inequity in library services, provided by libraries of all types, to the economically depressed, geographically isolated, and technologically unconnected communities across the nation.

Operational and material costs continue to rise. To align with the ALA's motto: "The best reading, for the largest number, at the least cost," I believe that we must leverage available digital technologies to help us in reconfiguring our organizational structures as well as in developing new programs and services to serve users across geographical boundaries without spending a significant amount of our limited resources.
