## Current:

12 Members
4 - Elected by Membership: President, President Elect, Immediate Past President, Treasurer
8 - Elected by Council (Council is elected by Membership)
1 - Staff (Executive Director, ex officio)

## Future:

17 Members
4 - Elected by Membership: President, President Elect, Immediate Past President, Treasurer
8 - At-Large Members Elected by Membership
5 - Appointed by the Executive Board for unique skills and perspectives not represented by elected members.
1 - Staff (Executive Director, ex-officio)

3 Executive Board Committees

## Leadership Assemblies

## Current:

Direct correlations do not currently exist, but the recommended approach tries to consolidate and expand upon current meetings such as the Chapter Councilors Forum, Chapter Leadership Forum, and the Round Table Coordinating Assembly.

## Future:

Division, Roundtable, and Chapter Assemblies (1 each, 3 total) will provide an open communication exchange to and from the ALA Executive Board and members. These assemblies will offer input to the ALA Executive Board on critical issues facing their participants, serve as a forum for integrated planning and prioritization, and share effective practices.

- Adhere to a shared operating agreement
- Adopt the same dues structure.
