STATEMENT: CMDS is the obvious choice to play a leading role in defining how libraries meet the challenge of providing affordable access to information, whether through encouraging the "open access" movement or through other strategies that will at least include an open access element. Collection developers also must address the need to preserve the electronic content that has come to dominate our recent collecting but that also can prove so elusive to save for the future. I would consider it a privilege to work on the pressing issues confronting collection development as the chair of CMDS; I would also consider it a privilege to encourage the continuation of our efforts in education and publishing. For it is certain that collection development will remain a most important function of libraries well into the future.

When planning a program on union listing, we made a successful proposal to the ALCTS Board to invite co-sponsorship from other groups outside of ALCTS to whom union listing was important. While this is more common now, at the time it was the first time such a proposal had been made. I cannot claim credit for the great program name "The Serials Pig in the Aggregators' Poke", but as co-program planning chair I do take pride in having helped to organize a program that had technical services and public services people actually having a conversation – a program which one person called "the best program (I've) ever attended at ALA". My diverse experience helps me to see the similarities and synergies among us rather than the differences, particularly as we approach collection development and management.

STATEMENT: I bring to this election 28 years of ALA membership, most of it serving ALCTS in sectional activities and much of it in a leadership role. While it may not be apparent, I have quite a bit of collection development experience. I am currently a selector, and have been one in both academic and special libraries and in both technical and public services positions. I find in the 21st century that I spend most of the time trying to manage increasingly electronic collections and much less time developing them. One of my goals on the Executive Committee would be to examine the current CMDS committee and discussion group structure to see if there are additions or changes that would help meet members' current needs. Another goal would be to look at increased synergies between CMDS, other sections in ALCTS, and other divisions in ALA. A great deal of programming on and discussion of collection development and collection management takes place in the ALCTS Serials Section, RUSA, even LITA. I would like to explore how CMDS can find additional ways to cross the divisional boundaries.

At Harvard: 1) I was the first e-resources coordinator for humanities resources within the College Library; 2) served on the OPAC advisory group. At Simmons, I am in the process of reorganizing our collections activities as we continue through a construction process with an eye towards a reorganized collection in our new building. Within ALA, beyond my involvement in various committees, I've also presented poster sessions, moderated an ACRL panel, maintained websites, and gave a presentation at the Toronto conference.

STATEMENT: Three areas of collection management stand out to me: 1) scholarly communication and the continuing serials crisis, 2) re-thinking our organizational systems and technical standards along with the growing reliance on networked electronic resources, 3) changing definitions of the local collection with the increasing speed of delivery/access to collections that are not locally-owned. We must continue to reconsider our involvement in the creation and dissemination of knowledge and be active in the development of new ways of creating collections that serve our communities in a cost-effective and easy-to-access manner. We must support the development of standards for ERMs and in other areas that will increase the interoperability of local and vendor systems. With collections, systems and public services work at various sizes and kinds of institutions, I believe that I have a broad perspective on issues of collection management that can benefit our section.

Over the past 22 years as an active member of ALCTS I have found its membership, governing and committee structures to be valuable resources. I would welcome the opportunity to address the issues
