ALA Leadership

I continue to feel fortunate to have such strong support and collegial relationships with ALA Leadership, Courtney L. Young, Barbara Stripling and Mario Gonzalez. The entire Executive Board and ALA staff has also provided guidance as I move forward to prepare for my first conference as President-Elect.

New York Publisher Visits

From December 1-3, I participated in the collective effort of the American Library Association to discuss the current and future state of ebook access in separate meetings with representatives of Macmillan Publishers, Penguin Random House, and Hachette Book Group. ALA President Courtney L. Young and the co-chairs of ALA's Digital Content Working Group (DCWG), Carolyn Anthony and Erika Linke, focused our conversation.. Also included in the group were immediate Past President Barbara Stripling, Executive Director Keith Michael Fiels, and Alan S. Inouye, the director of ALA's Office for Information Technology Policy.

The discussion focused on business models, preservation, pricing, marketing opportunities and increasing the relationship between publishers and libraries. This is particularly important to improve the discoverability and the access for library users. The dialogue is invaluable and ALA has certainly been a critical voice in improving access to Big Five content.

We also met with senior staff of the New York Public Library and the members of the board of trustees of the Metropolitan New York Library Council (METRO). In these meetings, we focused on digital content issues, the state of Big 5 publishers, and New York institution-based initiatives (for example, the [Library Simplified](#) project). ALA appreciated our productive exchanges with both organizations, and the Association looks forward to further developing our relationships on digital content and other library initiatives. There appears to be tremendous opportunity for ALA to be better connected to METRO and NYPL (as well as other NYC systems) and to deepen our connection to this large group of library professionals.

New York City Events

The annual I Love My Librarian Award Ceremony and Reception took place at the *New York Times* on December 2. Ten librarians were honored with the award sponsored by the NYT and the Carnegie Corporation. The emotional stories and moving testimonials to library services, are the fabric of our institutions. This inspirational reminder of the hard work and talent in libraries is a wonderful annual event.
