On Monday, January 27, the ALA Council referred ALA CD#38 to the Budget Analysis and Review Committee for a report back at the 2014 ALA Annual Conference

Resolution to allow programs at American Library Association (ALA) Midwinter Meetings

Whereas the purpose of Midwinter Meetings (A.7.4.11) states "The ALA Midwinter Meeting is convened for the primary purpose of expediting the business of the Association through sessions of its governing and administrative delegates serving on boards, committees, and Council. Programs designed for the continuing education and development of the fields of library service shall be reserved for Annual Conference except by specific authorization of the Executive Board acting under the provisions of the ALA Constitution. Hearings seeking membership reactions and provisions for observers and petitioners at meetings of Council, committees, and boards are to be publicized; programs of orientation or leadership development to Association business are encouraged; assemblies of groups of individuals for information sharing vital to the development of Association business shall be accepted as appropriate to the purpose of the Midwinter Meeting;"

Whereas the nature of Midwinter Meetings has evolved as a consequence of virtual business meetings;

Whereas Midwinter Meetings attract members from different geographical regions than Annual Meetings;

Whereas the number of programs at ALA Annual Conferences is limited;

Whereas the prohibition against conducting programs at Midwinter meetings has led to the use of discussion groups as an alternative;

Whereas public librarians have difficulty claiming that participating in discussion groups is a part of their professional development; and

Whereas all librarians face more difficulty getting credit for presenting at discussion groups rather than at programs: now therefore, be it

Resolved that the American Library Association (ALA) should:

1) Change policy A.7.4.11 to allow for programs designed for continuing education and development in the fields of library service.
