ANNOUNCEMENTS

Headquarters

Headquarters for the American Library Association and all the affiliated societies will be at the Grand Union Hotel.

Registration

Everyone in attendance at even one session, and whether a member of the Association or not, is requested to register at Headquarters at the Grand Union.

Members in arrears for dues and library workers wishing to join the Association will find the secretary or his representative at headquarters.

Information Bureau

An Information Bureau will be operated adjacent to Headquarters, and a local representative will be present at certain announced hours daily to answer questions, assist in making up parties to go to places of interest, etc.

Travel Committee

Members of the A. L. A. Travel committee will by turn be at A. L. A. Headquarters at certain announced hours each day to assist members of the Association in their travel arrangements.

Meeting Places

The places assigned for the various meetings will be found listed in the schedule at the end of this program.

General Sessions will be held in the Convention Auditorium, a short distance from the Grand Union. Sections and affiliated societies will in most cases meet in the Grand Union. Two or three meetings will be held at the Hotel American.

Informal Reception

There will be a very informal reception for the purpose of greeting old friends and making new ones, in the parlors of the Grand Union, Monday evening, immediately following the evening session.

Library War Service

A representative of the Library War Service will be located adjacent to Headquarters at certain announced hours of each day, for the purpose of giving information relative to the camp libraries, and other matters connected with the service rendered the military and naval forces.

Service Flag

Our Service Flag bears 298 stars—one a gold star, a memorial to Dudley Coddington, assistant in the Seattle Public Library, who was killed at Vimy Ridge, April, 1917. This flag represents all library workers who are *enlisted* in either the army or the navy, whether they are members of the A. L. A. or not. A number of men not of military age, and a large number of women are rendering valuable services to the country, some in the training camps, others in the Y. M. C. A. or Red Cross overseas, or in the Councils of National Defense, but these are not represented in the flag, the custom for service flags being adopted, that only *men* actually *enlisted* in the service be included.

Official Exhibits

There will be several notable exhibits at the Headquarters hotel, among them the following:

1. Library War Service—What the A. L. A. is doing for the men in service; through the Camp Libraries and other camp agencies, in the smaller army and navy posts and stations; how the books are shipped overseas, etc.

2. What the Food Administration wants libraries to do to further its publicity program. Libraries can do no more important work than to help the Food Administration in educating the public how it can and must conserve the nation's food.

3. Bookbinding—an exhibit of the committee, prepared by Gertrude Stiles, of the Cleveland Public Library.

Commercial Exhibits

A number of commercial exhibits of interest to librarians will be found at the Headquarters hotel, and all library workers in attendance at the conference are invited to inspect them and devote as much time to them as possible.

New York State Library Day

Saturday, July 6, will be observed as "New York State Library Day." The Association, its affiliated societies and friends are cordially invited to participate in the celebration of the one hundredth anniversary of the founding of the library. The program for the day will be as follows:

11 a. m.-12:30 p. m. Exercises in Chancellor's Hall, in the State Education Building, Albany. The principal address will be made by the chairman of the Library Committee of the Board of Regents, Hon. Chester S. Lord, of Brooklyn, or in case of his necessary absence, by Hon. Charles B. Alexander, of New York City. Brief addresses are expected from the architect of the building, Henry Hornbostel, and from former directors of the State Library, to all of which response will be made by President Montgomery.

1 p. m. A complimentary luncheon will be tendered by the Regents of the University, served in the Law Library on the second floor.

2-5 p. m. Conferences and visits of inspection to the New York State Museum on the fourth floor of the building and particularly to the different library divisions and sections. Despite the fact that Saturday is a half holiday the reading rooms are always open and the members of the staff will be in attendance at each division and section. Parties will be formed under competent guides to make a tour of the building; while those who do not care to join such parties, involving perhaps a mile or two of walk, will be welcomed in any section whose work may be of special interest.

Former students of the Library School will be asked to meet in a room to be designated later, in the Library School suite, for some special ceremony.

Good trains, east, west and south, leave in the neighborhood of five o'clock, and the New York boat leaves at eight. The exercises have been delayed until 11 a. m., so that there may be no unpleasant rush in getting down from Saratoga Springs, which is little more than an hour away.

The Education Building is but a few minutes walk from the Union Station; several car lines connect the two, so that it has not been thought necessary to provide special transfer facilities.
