Membership Update

Overall ALA Membership as of May 2010 stands at 62,251. While this is a slight decline of 1/3% from last year, personal membership is slightly ahead of last year at 58,982. Organizational and Corporate memberships are down approximately 8% each at 3,044 and 225 respectively. Members are taking a bit longer to renew, but they are renewing in good numbers.

Capwiz Milestone

A milestone has been reached as there are now 100,000 individuals subscribed to receive advocacy messages through Capwiz. Capwiz is available at no charge to ALA Chapters, is funded through the Chapter Relations Office, and is designed to support statewide advocacy efforts while helping to better integrate state and federal legislative advocacy.

Spectrum Presidential Initiative

The “Dinners for Spectrum Scholars” program is in full swing with dinners taking place across the country. The concept is simple: bring people together for a meal or night out and encourage them to make a donation to the Spectrum Scholarship Program. Annual Conference Update

As of Friday, June 11, attendee pre-registration for the 2010 ALA Annual Conference stood at 12,556, compared to 13,023 at this point for the 2009 Annual Conference. Registration is higher for several groups:

- There are 401 international attendees registered, compared to 358 in 2009.
- There are 1,106 students registered, compared to 1,042 in 2009.
- There are also 188 retired members registered, compared to 131 in 2009.

650 conference attendees have purchased tickets for the Scholarship Bash at the Newseum. 131 have registered for Libraries Build Communities volunteer service at three public libraries, 11 school libraries and other DC community organizations. Over one thousand have pre-registered for the Advocacy Day Rally on the Hill.

Staff from American Libraries, the Public Information Office, Membership Development and Conference Services will be expanding coverage of events, programs, socials and speakers during ALA Annual Conference this year through the ALA "Base Camp".

Look for enhancements on the ALA homepage from June 23 through July 1, including a Twitter feed tracking the conference tag 'ala10', a news tab aggregating blogs from around the association, and quick navigation to key conference resources. *American Libraries Magazine* hosts the full conference landing page at www.americanlibrariesmagazine.org/ala10 that shows the Twitter feed plus ALA's Flickr, YouTube, LinkedIn, expanded blog coverage, and daily online versions of Cognotes.

Virtual Conference

The ALA Virtual Conference -- two days of programming selected from sessions offered by groups across the Association, plus some special "virtual-only" sessions -- will be held on July 7 and 8. The live Virtual Conference has a separate registration, but will also be available after the live event to anyone registered for Annual Conference. The 2010 Virtual Conference features two "virtual-only" keynotes: George Needham and Joan Frye Williams will discuss "Creating Relevancy for Users" and Karen Hyman will discuss "Reinventing Your Library for 2010". There are also "virtual only" author lunches (bring your own lunch): Booklist's Brad Hooper will interview Dwayne Betts, and Donna Seaman will interview Adriana Trigiani.

Sessions selected from the main conference programs were recommended by sponsoring Divisions and other groups and are targeted to a broad audience including staff from different types of libraries and different job specializations. Session titles include:

At this point, there are 108 individuals and 26 institutions registered. Each institution has 15 "seats." This means that we can expect at least 500 participants. (Registration for individuals is \$69 and for institutions (up to 15 IP addresses) is \$300.) ACRL 2011 Registration Opens

Registration for the ACRL 2011 National Conference, "A Declaration of Interdependence," opened on May 19. The conference will be held March 30 – April 2, 2011 in Philadelphia. The early-bird registration deadline is February 4, 2011, for savings of more than 20 percent on conference registration. Special group registration prices, reduced airfares, hotel discounts, and scholarships are also available. ACRL 2011 registration opened earlier than in past years to allow increased flexibility and fit registration costs in the current fiscal year.

The ACRL 2011 National Conference will feature more than 300 peer-reviewed sessions specific to the needs of academic and research librarians and staff. Celebrated keynote speakers – Tiffany Shalin, Raj Patel, and Clinton Kelly – will inform and challenge. Take advantage of this unique opportunity to explore new ideas and consider the interdependency that exists in the academic and research library community. Elementary and Secondary Education Act

Jamie Greene, a school librarian at Hugh Cole Elementary School in Warren, RI, and President of the Rhode Island Educational Media Association (RIEMA), testified before the U.S. Senate Committee on Health, Education, Labor and Pensions (HELP), highlighting the critical role of school libraries in our nation's educational system and the need for Congress to include them in the reauthorization of the Elementary and Secondary Education Act (ESEA).

ALA is requesting that Congress include school libraries in ESEA by including the following three requests: 1) Having every public school have a school library staffed by a state-certified school librarian, 2) allowing for state and local professional development funds to be used for recruiting and training school librarians, and 3) maintaining dedicated funding for the Improving Literacy Through School Libraries.

Spectrum, Support Staff Certification grants received from IMLS

On Wednesday, IMLS announced the award of two grants to the association:

Discovering Librarianship: The Future is Overdue is a three-year program to recruit ethnically diverse high school and college students to careers in libraries. The program will enlist a cohort of 35 early career librarians to develop recruitment materials and serve as in-the-field recruiters. Field recruiters will be provided with funding to participate in 70 national, regional and local recruitment events. ALA will work to develop a leads/contacts management system into which interested leads can be entered and from which library schools and diversity initiatives can solicit interested applicants.

ALA will also host an institute for up to 50 college undergraduates interested in careers in librarianship, with information on preparing for graduate school admissions, selecting an LIS program, finding funding for graduate school, and making the most of graduate education in library and information science.

A second grant to expand the Library Support Staff Certification Program will allow ALA to:

- Increase the amount and diversity of LSSC candidates who enroll and successfully complete the program.
- Improve successful completion rate of candidates through robust support mechanisms.
- Increase the available courses and competency sets designed to improve the skills and knowledge of LSSC candidates
- Increase acceptance of LSSC among state library agencies and other certification organizations.
- Measure the LSSC program's impact on library services, employment practices, and individuals.

The project will include strategic marketing and promotion, scholarships, online tutorials for candidates and volunteers, grants to develop courses, exploration of acceptance by state library agencies, and an evaluation component that examines the changes in performance and service for participating support staff.

Education Assembly Meeting to Address Recent Library School Challenges

The ALA Committee on Education (COE) has the role of providing a networking platform for dialogue between LIS educators and practitioners. To help fulfill that role, the Committee has offered an open forum for discussion to Beth Paskoff, Director of the Louisiana State University Library and Information Science Program, and Linda Smith, Associate Dean of the University of Illinois Graduate School of Library and Information Science, at the Education Assembly during the ALA Annual Conference in Washington, DC. Both have accepted the invitation. This will enable Dr. Paskoff and Dr. Smith to have a national platform to discuss the issues concerning their programs and to garner the support of practitioners and others in the library community. The challenges they face include a potential closure of one program and the other's role within the university structure. This special assembly will also help COE define its role in looking into this matter on behalf of Council and in supporting the programs during these challenges. The forum will be held on Saturday, June 26, 2010, 4:00 – 5:30 p.m., Washington Convention Center, room 149A/B.

Haiti Relief at Annual

ALA members will have a new way to help rebuild libraries destroyed by the Haitian earthquake. At the upcoming Annual Conference, attendees will be offered the opportunity to make 'text' donations of \$10 through their mobile service provider to help rebuild libraries in Haiti. This is ALA's first 'text' donation effort.

StoryCorps Interviews

Twelve librarians have won a once-in-a-lifetime opportunity to do a personal [StoryCorps](#) interview with an admired mentor or colleague during the Annual Conference, courtesy of [American Libraries](#). To win their slots, contestants had to explain whom they wanted to interview—a mentor, colleague, or someone who inspired them in the profession—and why their relationship is important. StoryCorps is the award-winning, nonprofit oral history project that honors and celebrates the lives of everyday people through listening. This is the first time a group of librarians have been invited to contribute their stories. Like all StoryCorps interviews, the Annual Conference interviews will be archived in the American Folklife Center at the Library of Congress. In founding StoryCorps, Isay predicted that libraries and librarians would play a big role. At the program on Sunday, he will reveal how his prediction has played out. Isay—winner of a MacArthur “Genius” Fellowship—will sign copies of his new book, *Mom: A Celebration of Mothers from StoryCorps* (Penguin) following the program.

This year's Friday evening (8:00-10:00 p.m.) *Booklist* Books for Youth Annual Forum, “Comic World: Graphic Novels Come of Age” celebrates graphic novels with a program featuring comics creators and publishers Françoise Mouly (Editorial Director, Toon Books); Gene Luen Yang (author, First Second, an imprint of Roaring Brook Press); Mark Siegel, Editorial Director, First Second); and Matt Phelan (author, Candlewick Press). Keir Graff, *Booklist Online* Senior Editor, moderates, and the panelists are: Otis Chandler, the founder and CEO of the successful social-media site *Goodreads*; Ron Charles, the Deputy Editor of the *Washington Post Book World* and a widely followed Twitter user; Jon Fine, Director of Author and Publisher Relations for Amazon.com, whose customer reviews have been a powerful agent of change; and Jennifer Hubert Swan, who is the author of the popular *Reading Rants* blog, a veteran reviewer, and a middle school librarian at the Little Red School House and Elisabeth Irwin High School in New York City.

On Monday morning (10:30 a.m.-12:00 noon), Sue Polanka (Head of Reference Instruction, Wright State University), moderates the ever-popular Reference Books Bulletin program, this year addressing “Reference Work from Idea to Reality.” The speakers will look at how an idea gets turned into an encyclopedia or reference database, and then how a publisher keeps it vital—the process of creating and updating reference works in print and online. The speakers are Casper Grathwohl (Oxford University Press, Vice President and Publisher of Reference); Rolf Janke (SAGE Reference, Vice President); and Frank Menchaca (Gale, Executive Vice President, Publishing).

ALA has set up an option to allow individuals to 'text' \$10 donations through their mobile phone service.

Funds will help rebuild three individual libraries destroyed by the earthquake in January: The Petit Goave Public Library, the Centre Culturel Pyepoudre Community Library, and the Bibliothèque Haïtienne des Pères du Saint-Esprit, which was founded in 1873 and holds resources documenting the history of Haiti, French colonization, slavery and emancipation.

Over the past month, several groups have donated to the Spectrum Presidential Initiative:

- Virginia Public Library Directors Association has donated \$600 to SPI. The group members donated \$300 in cash for the Spectrum Scholars program at a recent meeting, and the Association matched the \$300, for a total contribution to the Spectrum Scholars program of \$600.
- The Association of College & Research Libraries (ACRL) has announced a two-year commitment to the Spectrum Scholarship Program as part of the Spectrum Presidential Initiative. ACRL will sponsor one scholar each year for 2010 and 2011. The ACRL Spectrum Scholarships will be awarded to a Spectrum applicant who expresses an interest in academic and research libraries.
- The ALA staff, through a Spectrum Pizza Party, organized by the ALA Office for Diversity and Spectrum Scholarship Program, raised \$1,000 for the Spectrum Scholarship Program and Spectrum Presidential Initiative.
- The Tennessee Library Association (TLA) announced its support of the Spectrum Presidential Initiative with a contribution of \$500. The TLA Board of Directors and Executive Committee voted unanimously to make an annual donation in this amount to the Spectrum Scholarship Program.

Federal Research Public Access Act (FRPAA)

On April 15, 2010, Representatives Doyle (D-PA), Waxman (D-CA), Wasserman-Schultz (D-FL), Harper (R-MS), Boucher (D-VA) and Rohrabacher (R-CA) introduced the Federal Research

Public Access Act (H.R. 5037), a bill that would ensure free, timely, online access to the published results of research funded by 11 U.S. federal agencies (as the National Institutes of Health (NIH) Public Access Policy does now). This bi-partisan supported bill mirrors the Senate version (S. 1373) introduced in June 2009.

A message was posted to the ALA's Legislative Action Center asking members to write to their representative asking her/him to support and co-sponsor H.R. 5037.

Director of the Sacramento Public Library System Testifies in House Broadband Hearing

Rivkah Sass, Director of the Sacramento Public Library System, testified before the United States House of Representatives Committee on Energy and Commerce's Subcommittee on Communications, Technology and the Internet on May 13.

The hearing, titled "The National Broadband Plan: Promoting Broadband Adoption," was the fourth in a series of hearings addressing issues raised in the National Broadband Plan. It examined recommendations in the National Broadband Plan for increasing broadband adoption, including ways to ensure that all Americans are able to subscribe to broadband and ways to educate individuals about broadband's benefits. Ms. Sass's testimony highlighted the critical role of libraries as anchor institutions in helping drive broadband adoptions in communities.

Obama Announces Nomination for Public Printer

President Obama announced his intention to nominate William J. Boarman for the position of Public Printer of the United States. Mr. Boarman is currently the President of the Printing, Publishing & Media Workers Sector of the Communications Workers of America (CWA) and the Senior Vice President of CWA and has previously worked for the Government Printing Office. His nomination must be confirmed by the U.S. Senate, and the Senate Rules Committee held a hearing on May 25 at which Mr. Boarman was a witness.

Renewed Effort on the PATRIOT Act

OGR was involved in numerous coalition meetings in May to discuss how to move forward on PATRIOT and other privacy issues. In particular, the groups are looking at how to educate the public before the next provisions sunset to increase grassroots support when these issues are again before Congress.

Library Advocacy Day Preparations Still Underway

Preparations for Library Advocacy Day continue. Registration for this event, which will be held on June 29, 2010 at Upper Senate Park, continues to grow. As of June 7, 2010, over 1000 participants have registered for the rally. On Monday, May 24, the ALA Washington Office sponsored a webinar titled "Library Advocacy Day: What to Know Before You Go." This online training session had over 200 participants. Throughout the Annual Conference, there will be many opportunities to learn more about the rally and how to get involved.

On Saturday, participants should attend the training session, "What to Know Before You Go" from 10:30 a.m. to noon in WCC-103B or visit the Membership Pavilion from noon to 1 p.m., where volunteers will be available to answer questions and register individuals for the event.

Sunday will offer more Q&A time at the Membership Pavilion from noon to 1 p.m. and again from 2:30 to 3:30 p.m. On Monday, volunteers and staff will be available to answer questions at the Membership Pavilion from 11:30 a.m. to 12:30 p.m. and again from 2:30 to 3:30 p.m.

An Advocacy Hour will be held at 1 p.m. on Saturday, Sunday, and Monday at the Membership Pavilion. Attendees are encouraged to come and learn about all the ways to get involved in library advocacy, as well as ask questions about Library Advocacy Day.

Messages to Congress

As of June 7, 2010, over 12,900 messages have been sent to Congress. 13,206 messages were sent to Congress in all of 2009. At this rate, ALA's messages to Congress will be double last year's numbers by the end of the year.

Elementary and Secondary Education Act

Since Congress failed to reauthorize the Elementary and Secondary Education Act (ESEA) in 2009, they have the opportunity for reauthorization in 2010. Both the Senate and House have been holding hearings and meetings on what should be in a reauthorized ESEA bill. During this time, the Washington Office has been meeting with key members and staff on what needs to be in ESEA for libraries.

Jamie Greene, a school librarian at Hugh Cole Elementary School in Warren, RI, and President of the Rhode Island Educational Media Association (RIEMA), testified before the U.S. Senate Committee on Health, Education, Labor and Pensions (HELP) in a hearing titled, "ESEA Reauthorization: Meeting the Needs of the Whole Student."

Greene's testimony highlighted the critical role of school libraries in our nation's educational system and the need for Congress to include them in the reauthorization of the Elementary and Secondary Education Act (ESEA).

ALA is requesting that Congress include school libraries in ESEA by including the following three requests: 1) Having every public school have a school library staffed by a state-certified school librarian, 2) allowing for state and local professional development funds to be used for recruiting and training school librarians, and 3) maintaining dedicated funding for the Improving Literacy Through School Libraries. It is unlikely that the Congress will reauthorize ESEA this year. However, Health, Education, Labor and Pensions (HELP) Committee Chairman Tom Harkin (D-IA) wanted to mark up a bill in the Senate by early June. No date yet has been set for such a mark-up.

Office for Information Technology Policy (OITP)

ALA Files Comments on the National Education Technology Plan

On behalf of ALA and in coordination with the American Association of School Librarians (AASL), OITP filed comments on the draft National Education Technology Plan. The comments informed the U.S. Department of Education of the numerous ways school libraries integrate innovative uses of technology into the nation's schools and prepare students to thrive in the 21st century. The development of the comments was aided by expert advice from practicing school librarians, including Joyce Kasman Valenza who also serves on OITP's America's Libraries for the 21st Century Subcommittee, and Chris Harris, who serves on the OITP Advisory Committee.

OITP Outreach Activities

In April, OITP Director Alan Inouye was a guest speaker at the School of Information at the University of California at Berkeley. As a member of Google's Consumer Advisory Group, Alan also participated in a two-day meeting at Google Headquarters. A key purpose of this Group is to provide Google with public interest perspectives to help the corporation shape its products and practices. Other members of this Group include the American Civil Liberties Union (ACLU), the Association of Research Libraries (ARL), EDUCAUSE, Consumers' Union, Public Knowledge, and Free Press.

Final E-Rate Training Held in May

This May marked the final E-rate training for state E-rate coordinators of a three year project funded by the Bill & Melinda Gates Foundation. The two-day training covered numerous topics that state coordinators need to know in order to help their home libraries participate in the E-rate program. This spring, with the release of the National Broadband Plan by the Federal Communications Commission, part of the training session was devoted to a presentation, and discussion of the recommendations in the Plan related to the E-rate program. There were coordinators present from 41 states and the territories.

ALA Washington Office Hosts CopyNight

On May 25, the Washington office hosted CopyNight DC, a monthly gathering for discussing current issues in copyright and technology. Carl Malamud of PublicResource.Org, an Internet pioneer and information access activist, was this month's guest speaker. He gave a talk on the law.gov project to make primary legal sources more accessible to the public, as well as several volunteer projects to digitize public domain materials only available in person at the National Archives. Special guest Brewster Kahle of the Internet Archive joined Mr. Malamud. Attendees came from a variety of DC-area organizations in policy, technology, academia, and government.

Office for Intellectual Freedom (OIF)

Choose Privacy Week, 2010

A film featuring Neil Gaiman, Cory Doctorow, Geoffrey Stone, and ALA President Camila Alire discussing some of today's most interesting and complex privacy issues provided the cornerstone for the first-ever Choose Privacy Week, held May 2-8, 2010. Bloggers and others across the web promoted the video, which has been viewed 14,000 times since its debut on May 2.

Choose Privacy Week events took place in Florida, Indiana, Massachusetts, Maine, Missouri, New Hampshire, Ohio, Pennsylvania, Rhode Island, Vermont, and Virginia. Over 160 persons attended an Association of College and Research Libraries (ACRL) online Choose Privacy Week event, and 44 librarians participated in an online workshop on learning how to host community forums on privacy. Over 50 libraries blogged about Choose Privacy Week, and BoingBoing, Unshelved, LISNews, and CILIP were among the blogs and online news sites that highlighted Choose Privacy Week.

Organizing for Choose Privacy Week 2011 is now underway. Plans include the release of the Privacy video on DVD for schools and libraries, expanded programming for children and youth, and strengthened alliances with our privacy partners, including the Center for Democracy and Technology, the Electronic Frontier Foundation, the American Civil Liberties Union, and the Campaign for Reader Privacy.

Martin Garner, chair of the ALA Intellectual Freedom Committee, will moderate the panel, which will take place Monday, June 28 from 10:30 a.m. - Noon, in the Washington Convention Center's Room 146B.

Revised Intellectual Freedom Manual Debuts at ALA Annual

The newly revised and updated eighth edition of the Intellectual Freedom Manual will make its debut at the 2010 ALA Annual Conference in Washington, DC. A convenient reference guide for librarians and library trustees addressing intellectual freedom and privacy issues in their libraries, the eighth edition of the Manual includes up-to-date legal information on censorship, minors' rights, and the USA PATRIOT Act, three new Interpretations of the Library Bill of Rights,

FTRF Roll of Honor Award Given to Robert O'Neil

Robert M. O'Neil, Director of the Thomas Jefferson Center for the Protection of Free Expression at the University of Virginia (UVA), is the recipient of the 2010 Freedom to Read Foundation (FTRF) Roll of Honor Award. O'Neil, who also serves on the law faculty at UVA, has a storied history as an advocate for the First Amendment. He began his legal career as a clerk for Supreme Court Justice William J. Brennan, Jr., in 1962, and from there held a number of

positions in academia, including President of the University of Virginia. He is also a member of the National Advisory Board of the American Civil Liberties Union.

O'Neil was the keynote speaker at FTRF's 10th Anniversary Gala in 1979. At the Foundation's 40th Anniversary Gala in 2009, he presented the Thomas Jefferson Center's William J. Brennan Award for free expression posthumously to FTRF Executive Director Judith Krug.

Online tools for librarians include program logos in both English and Spanish, a downloadable poster and bookmarks and a toolkit that includes sample press materials and programming ideas.

Communities thrive @your library for National Library Week, April 11 – 17

The National Library Week (NLW) theme this year (April 11 – 17) was Communities thrive @your library with Neil Gaiman as the honorary chair. This year's publicity efforts resulted in more than 4,500 articles and mentions, with a circulation total of 232 million. More than 225 blogs posted NLW event information and more than 2,270 people tweeted about NLW related activity. Participating libraries produced more than 50 YouTube videos.

A great deal of NLW media coverage focused on the release of the ALA Top Ten List of Frequently Challenged Books. PIO "pitched" the release of the list to the Associated Press (AP). AP coverage of the list resulted in thousands of national and international placements.

PIO worked closely with ALA President-elect Roberta Stevens and the SirsiDynix Institute to produce a PowerPoint presentation and script that detailed this year's key findings. American Association of School Librarians (AASL)

AASL Teams Up with Capstone to Offer Licensed Institutes

Beginning this summer, the American Association of School Librarians (AASL) and Capstone are teaming up to offer "Empowering 21st Century Learners: P21 Framework and AASL Learning Standards" licensed institutes. Through the generous support of Capstone, funding will be given to fourteen groups chosen by AASL to cover 50% of the cost per institute. "Empowering 21st Century Learners" is a one-day institute designed to help school librarians understand how AASL's "Standards for 21st-Century Learner" and the framework of the Partnership for 21st Century Skills (P21) align to make it easier for integration into a school or district's current and future practices.

AASL Offers Two Online Courses for Summer 2010 with the Option for Graduate Credit Hours

The American Association of School Librarians (AASL) will offer two summer 2010 online courses focused on helping school librarians discover new ways to bring their programs into the 21st century. From Monday, May 31 to Friday, June 25, AASL will offer "Making a Place, Making a Case for Read-Alouds: A Powerful Teaching Tool for Literacy K-6." The course is facilitated by Christina Dorr and Liz Deskins. "The Path to Collaboration: Making it Happen" will be offered Monday, July 12 – Friday, August 6, and will be facilitated by Marilyn Heath. Both of these courses are self-paced. From now until July 19, participants can register with the University of Colorado Denver School of Education & Human Development Program to earn up to 2.0 graduate credits hours.

New Grant Cycle Offers More Money to School Library Programs Affected by Natural Disasters

The *Beyond Words* grant targets public school libraries nationwide that have suffered materials losses because of a major disaster. Funds are to be used for purchasing books, media, and/or library equipment that support learning in a school library environment. To date, the grant has given over \$1.6 million to more than 100 school library programs across the U.S. Only public school libraries are eligible for the grant. Individual awards are for \$5,000 to \$15,000. The amount awarded is based on the level of destruction and/or hardship the library has suffered. Funding for this program is provided by Dollar General.

AASL's Fall Forum 2010 Opens for Registration, Announces Programming

Registration is now open for the American Association of School Librarians (AASL) Fall Forum. "In Focus: The Essentials for 21st-Century Learning" will be held November 5-6, 2010 in Portland, OR. Using AASL's learning standards and program guidelines, "In Focus" attendees will connect school library programs to current educational concepts at the core of curriculum, and leave with new insight to encourage, elevate and evaluate information literacy in their programs. The three breakout sessions will be led by Gail Dickinson, Leslie Maniotes and Ross Todd. As experts in the school library field and these essential skills, they will help attendees delve deeper into essential questions, enduring understanding and evidence-based practice. The keynote speaker will be Paige Johnson, global manager of K-12 education for Intel's Corporate Affairs Group and past-chair of the Partnership for 21st Century Skills (P21).

AASL to Offer School Librarians an Online, Interactive Planning and Advocacy Tool

The American Association of School Librarians (AASL) has joined with Britannica Digital Learning to co-publish an online, interactive school library program planning module that will change school library program development and implementation, saving time and delivering data. "A Planning Guide for Empowering Learners" is a program evaluation, planning, implementation and advocacy tool that will ensure school library program planners go beyond the basics to provide goals, priorities, criteria, and general principles for establishing effective library programs. The guide includes a revised "School Library Program Rubric," a tool that allows school librarians to assess their program on 16 different sets of criteria. From 2001 to 2009, Dr. Berman served as Director of the San Diego Supercomputer Center (SDSC), where she led the evolution of SDSC into a leading international organization in the innovation of data cyberinfrastructure and high performance computing.

ALA President's Award for Advocacy – Sponsored by ALTAFF

ALTAFF's first annual Advocacy Award will go to the Florida Library Association (FLA). In 2009, under strong pressure to reduce the overall state budget, the Florida State House Appropriations Committee decided to zero out funding for libraries altogether. The State Senate Appropriations Committee followed suit. The only hope for reinstating funding was a 72-hour "cooling off" period before any decisions were official. During those 72 hours, FLA crafted messages and asked that their members contact their Friends and Trustees to make calls and e-mail their representatives. They also urged members to use Capwiz, an online legislation and advocacy tool, to contact their representatives, using the message and talking points developed there. FLA worked with a public relations firm to get the word out about the pending elimination of state aid to libraries. Thanks to this immediate campaign, as well as its ongoing public awareness campaign, the FLA's advocacy resulted in the reinstatement of the state's library funding.

The 2010 ALA Presidential Award for Advocacy winner, the Florida Library Association, will be recognized at the Annual Conference Opening General Session.

Turning the Page Comes to a Close

In 2007, PLA and public libraries received a generous grant for advocacy training from the Bill & Melinda Gates Foundation. As a result, the groundbreaking program, *Turning the Page: Building your Library Community*, was developed. This advocacy education component was designed for public libraries participating in the Gates Foundation Opportunity Online hardware grants program.

The program drew to a close on May 31, 2010 after benefiting more than 3,500 librarians and library supporters across 32 states. Following training, the vast majority of participants were better advocates for their libraries—feeling more confident in their abilities and more excited about advocacy. As a result, over 98% of participating libraries achieved their funding goals.

Public librarians will soon have the opportunity to complete Turning the Page online for free. Through the generosity of the Foundation, PLA is currently updating Turning the Page for release this summer. This interactive, web-based training guides participants through the creation of an advocacy work plan. Library staff and supporters learn how to create and tell the library's story, deliver effective presentations, develop a compelling case for support, and build and sustain partnerships along the way.
