# ALA Executive Board 2008 Fall Board Meeting

**TOPIC:** E-Signatures – ALA Petitions

ACTION REQUESTED: Approval of interpretation of ALA policy

**DRAFT MOTION:** The ALA Executive Board supports use of electronic

signatures wherever the ALA Constitution, Bylaws and Policy Manual require members to petition for candidacy

or other action.

#### BACKGROUND:

The Electronic Participation Task Force recently forwarded requests from members for an e-petition for Council candidates. ACRL recently sought authorization to implement electronic signatures on petitions for new interest groups. Staff has reviewed ALA policy which, while clear on where petitions are required, is silent on what constitutes a "signature."

#### ALA Constitution, Article VI Council, Sec. 4 (c)

Any action of Council may be set aside by a majority vote by mail in which one-fourth of the members of the Association have voted. Such vote by mail shall be held upon **petition** of one percent of the personal members as certified by the Executive Director of the Association.

#### ALA Bylaws, Article II Meetings, Sec. 2 Special Meetings

Special meetings of the Association may be called by the Executive Board, and shall be called by the President on request of [indexed as "petition"] not less than five percent of the voting members of the Association as of the previous July 1, such request to be filed with the executive director at least ninety days before the proposed meeting. At least one month's notice shall be given, and only the business specified in the call shall be transacted.

#### ALA Bylaws, Article III Nominations and Elections, Sec.3 (b)

The ALA Nominating Committee shall also include on the official ballot other nominations filed with the executive director by **petition** of any twenty-five members of the Association at least four months before the annual conference, provided written consent of these nominees shall have been filed with the executive director of the Association.

## ALA Policy Manual, 6.2.1 Petitions for Establishment of New Units of ALA

Minimum acceptable standards for petitions requesting the establishment of new divisions, round tables, and other units of ALA are:

- 1) The purpose of the petition shall be clearly stated on a single sheet attached to each group of signature pages.
- 2) Each signature page shall contain this statement: "I favor this petition to...."
- 3) Petitioners shall sign and give library affiliation legibly. Failure to do so may result in the invalidation of the petition.
- 4) Information about this format and a sample petition will be supplied from ALA headquarters to anyone inquiring.
- 5) Petitioners shall be personal members of ALA.

ALA and its divisions and round tables likewise require petitions from members to establish new interest groups and/or discussion groups within the unit.

There is no legal impediment to the use of e-signatures. Practically speaking, it is necessary that the Association be reasonably assured that (a) the person is a member and (b) is who they purport to be. Traditionally, petitions have provided an acceptable level of assurance by requesting a membership number and library affiliation, along with a signature. Log-in/password processes can provide a comparable level of confidence.

Staff therefore recommend that the ALA Executive Board support the use of electronic signatures in any circumstance under which ALA policy requires a petition signed by members. Based on current resources, an electronic petition process may be available for nomination petitions beginning with the spring 2009 election (petitions available by December 2008). An electronic petition process for formation of ALA entities is projected for spring 2009.

Development of two types of online petitions is recommended:

### (1) Nomination for office -

- O It must be possible for a prospective candidate to initiate a petition to run for <> office, including name of office, name of candidate, year of election.
- The petition for that candidate must be accessible on the ALA web site, so that individuals choosing to support the candidacy may login and sign the petition, using name, place of employment and ALA member number.
- When completed (i.e., when the requisite number of signatures are collected)
  the petition should be directed to the ALA executive director and the
  candidate to the appropriate site to enter biographical information for the
  ballot.

#### (2) Formation of a new ALA entity

- It must be possible for an ALA member to initiate a petition to form a new ALA entity, in accordance with the requirements of the parent body (ALA, ALA division, ALA round table), including name of proposed entity, location within ALA (e.g., <> interest group/ACRL, <> member initiative group/ALA), proposed purpose of entity.
- The petition for formation of the entity must be accessible at an appropriate location on the ALA website, so that individuals choosing to support formation may login and sign the petition, using name, place of employment and ALA member number.
- When completed (i.e., when the requisition number of signatures are collected) the petition should be directed to the appropriate authorizing body.

In both cases, a list of persons who have signed the petition should be visible, without displaying the membership number or other private information.

Lois Ann, we will ask the Executive Board, at their Fall meeting, to approve an \*interpretation\* of ALA policy (which is basically silent on this topic, as far as I can find) authorizing e-signatures on petitions. I raised this with the Board's executive committee today, so they are expecting such a recommendation.

I also have received a request, from ACRL, to allow e-signatures for petitions to establish interest groups within ACRL. A number of divisions require member petitions to establish new groups, as does ALA with the MIGs (as well as new RTs, etc.). Once one division moves on this, others will -- if they have not already quietly done so.

I am proposing a fairly broad authorization for any place member signatures are required within the ALA member structure/ALA policy. (Based on Paula Goedert's advice, we will continue to seek paper signatures on some business agreements/contracts.) We will want to be \*reasonably\* certain that people are who they say they are and are members. I'll discuss that with ITTS and see what process they recommend.

Janet, do you see the need to limit this in any way -- or should we assume that if ALA policy requires signatures in order to run for office/form something/refer something to a vote of membership, e-signatures will be accepted. I am not suggesting any particular limitations, just checking....

Until I talk with ITTS, I don't know if this is something we can have in place for this Council election -- but I'll find out.

I agree with Jim - that the technology is there to allow for this and is something ALA might look into - it would probably require each member who wanted to use to establish an "electronic" signature that would be password protected on the ALA server. This would allow a person to electronically sign and allow those that receive the electronic signature to trust that signature as real.

This is esentially what you do in a terporary fashion when you file your income taxes electronically.

We were using electronic signatures increasingly at Lockheed Martin before I retired as more and more forms were keep only in electronic form -- those individuals who were required to sign these forms created an electronic signature that was password (and a complicated one -you know with mixture of letters, numbers, symbols, capital letters and had to be some horible length like 24 characters)protected.

Acceptance of electronic certifications and signatures has already been underway for many kinds of transactions in business and public sector. I should think that there would be a way for such matters to be handled by ALA.

Running for ALA Council may be especially difficult for those who live in sparsely populated areas where there may not be 25 ALA Members within a 300 mile radius. Electronic signatures on petitions to run for Council may help to broaden the representation on Council.
