### Library Card Sign-up Month

Library Card Sign-up Month kicked off on September 1. Promotional activities through [atyourlibrary.org](http://atyourlibrary.org) include sample tools featuring Library Card Sign-up Month Honorary Chair Troy Polamalu of the Pittsburgh Steelers; sample downloadable Facebook banners for libraries and library supporters; blog posts by parents/bloggers about why library cards are important to their families; a slideshow featuring ways to use a library card and more. PIO also developed a web press kit, press release and Public Service Announcements (PSAs) to support publicity efforts. Audio PSAs will air during the month in New York, Los Angeles, Chicago, San Francisco, Washington, D.C., Seattle and on Spanish language stations in San Diego, CA, reaching millions of listeners.

### 50 State Salute to Banned Books Week

This year marks the 30th anniversary of Banned Books Week, the national book community's annual celebration of the freedom to read. To commemorate this milestone anniversary, the Office for Intellectual Freedom is coordinating a "50 State Salute to Banned Books Week." The "50 State Salute" will form the core of ALA's participation in this year's Banned Books Virtual Read-Out and will consist of videos from ALA Chapters proclaiming the importance of the freedom to read. ### United for Libraries!

ALTAFF has changed its name to United for Libraries: the Association of Library Trustees, Advocates, Friends and Foundations but will be more "affectionately" known simply as United for Libraries. The name change became official on September 4.

### National Friends of Libraries Week, October 21-27

United for Libraries is gearing up for its seventh annual National Friends of Libraries Week, October 21-27. In preparation for this, a free webinar will be available and later webcast to show Friends and Librarians the many ways in which they can highlight the important contributions Friends of the Library groups make throughout the year.

## ALA Supports Vote 411

The ALA Washington Office is encouraging librarians to use their library's website to promote Vote 411, a new tool the League of Women Voters provides that helps people register to vote, and offers information on voting requirements and state deadlines. The American Library Association's support of Vote 411 comes off the heels of the ALA Council's unanimous passing of the resolution opposing voter suppression at the recent 2012 ALA Annual Conference. The Vote 411 tool allows users to build an online voter's guide, view political races, compare candidate positions side-by-side and print out "ballots" that can be used to remind the public to vote on Election Day. The tool also provides visitors with helpful voting information, candidate statements and details on current issues.

## New Ebook Business Models Report

In August, ALA released "Ebook Business Models for Public Libraries," a [report](#) that describes general features and attributes of the current ebook environment and outlines constraints and restrictions of current business models. Additionally, the timely report suggests opportunities for publishers to showcase content through public libraries. The report was created by the ALA Digital Content & Libraries Working Group (DCWG).

## ALSC National Institute

The [ALSC National Institute](#) is right around the corner, September 20 – 22, 2012, and ALSC is gearing up for a fantastic event. The theme of this year's Institute, "Libraries Leading the Race," illustrates the importance of libraries leading the way into the future and is supported by the Institute's great educational programming and speakers. A number of award-winning authors and illustrators will be present at the Institute, and the event is the kick-off to the Caldecott Award's 75<sup>th</sup> Anniversary Celebration with a very special Breakfast for Bill panel featuring past Caldecott Award winners.

## LITA Forum

2012 is the Columbus, Ohio bicentennial year, and the LITA Forum theme, *New World of Data: Discover. Connect. Remix*, builds on that celebration. The LITA Forum is highly regarded for bringing together librarians and technologists to teach, to learn, and to share in the expertise, the challenges, and the fun of exploring new and leading edge technologies. Three keynote speakers, Eric Hellman, Ben Shneiderman, and Sarah Houghton will provide a framework for the 40+ concurrent sessions. All types of libraries are represented in the programming and poster sessions. Two preconferences provide in-depth excursions, one into Web Analytics, and the other into core issues of systems management. Multiple networking opportunities are built into the schedule to provide all participants a chance to explore ideas, issues, problems, and answers with each other, LITA leaders, and Forum speakers. ### New Copyright Law Book Available for School Librarians and Educators

ALA released *Complete Copyright for K–12 Librarians and Educators*, a copyright law guidebook specifically written for teachers and librarians. The book, put forth by the Office for Technology Policy, addresses the challenges that school librarians and teachers face concerning copyright-protected print and online materials at schools and outside of the traditional educational environment. The book, which includes original illustrations by cartoonist Jessica Abel, explores complex situations often encountered in classrooms, such as the use of copyrighted material for school assignments, library operations, extracurricular activities and on the Web. ### New ALA Graphics Homepage

A [new ALA Graphics homepage](#) launched in August, bringing product and event information together with recommendations specific to school and public libraries, links to the ALA store, and subscription management information, as well as opportunities for customer feedback. At the same time, [a Tumblr blog](#) was launched that will feature regular content about Graphics products as they intersect with popular culture and events.

### Dollar General Literacy Foundation Grant Awarded to ALSC, YALSA

ALSC teamed up with the Young Adult Library Services Association (YALSA) to win continued grant support from the Dollar General Literacy Foundation. The grant will help ALSC fund resources and marketing for El día de los niños/El día de los libros (Children's Day/Book Day) in the form of Día book clubs.

### IMLS Grant for Digital Literacy Online Resource Collection

PLA has been awarded a two-year grant of \$291,178 from the Institute of Museum and Library Services (IMLS) to collaborate with ALA's Office for Information Technology Policy (OITP), the Chief Officers of State Library Agencies (COSLA) and the independent organization Connect2Compete (C2C) to develop an online collection of digital literacy resources that will be accessible to libraries, patrons, and other community-based organizations. The grant would also support the development of training programs and mechanisms for assessment and evaluation of said resources, and engage librarians and other practitioners in expanding and using these materials. The project stems from the need for consistent, quality, accessible digital literacy education, particularly in light of an upcoming national effort by C2C to improve digital literacy and broadband adoption to be supported by an Ad Council Campaign encouraging users to search out free online tools and education at their local libraries. ### ALA's First Single-Book Awards for Adult Trade Fiction and Nonfiction Awarded in Anaheim

Adult book award history was made at the ALA Annual Conference in Anaheim with the announcement and presentation of the first ever [Andrew Carnegie Medals for Excellence in Fiction and Nonfiction](#), funded through a grant from Carnegie Corporation of New York and cosponsored and administered by *Booklist* and the Reference and User Services Association (RUSA). The standing-room-only crowd in Anaheim was among the first to hear which two

books were chosen as winners (each receiving a medal and \$5,000) from the shortlist of six announced in May. Anne Enright's *The Forgotten Waltz* won for fiction, and Robert K. Massie's *Catherine the Great: Portrait of a Woman* for nonfiction. The selections reflected the expertise of the committee of librarians and *Booklist* editors, all of whom work closely with adult readers.

## ALA OFFICES

### International Relations Office (IRO)

#### ALA Leaders and Members Make Global Connections at IFLA in Helsinki

ALA President Maureen Sullivan represented ALA at this year's International Federation of Library Associations and Institutions (IFLA) World Library and Information Congress in Helsinki Finland, August 11-17, with support from President-elect Barbara Stripling and Immediate Past President Molly Raphael. ALA members serve on the IFLA Governing Board and IFLA section committees. There were many ALA members among the 400 strong U.S. delegation, also including many ALA international members, in attendance. Many members contributed with papers and poster sessions. ALA's exhibit booth was once again one of the most popular stands, and before the conference was over ten new international members had been recruited. ### Membership Development

#### July ALA Membership is 59,675

The ALA July membership count was 59,675, down 728 members, compared to the same period in 2011. Three divisions and five roundtables had membership increases.

#### Retention Program for Non-Renewing First-Year Members

A special retention program of regular first-year members who did not renew for their second year of membership launched in June. Preliminary results are 60 renewing members. Additionally, a special promotion to help address the lagging renewal of small/very small libraries launched in June, with preliminary results approaching 70 libraries.

#### ALA-Chapter Membership "packages"

Membership Development and the Chapter Relations Office continue to work with state chapters to develop and expand joint ALA-Chapter membership "packages" for students,

trustees and support staff. Special ALA online applications became available, making the process of simultaneously joining the ALA, participating divisions/round tables, and participating chapters easier. Through June 3, 200 members joined through the joint programs. The programs are being promoted locally by the chapters, on the ALA chapter web pages and on the ALA membership web pages.

## **Office for Government Relations (OGR)**

### Library Copyright Alliance Touts Copyright Exceptions at International Assembly

For the last four years, advancement toward more flexible copyright law continues in earnest at the World Intellectual Property Organization's 24th Copyright and Related Rights Standing Committee session (SCCR), which began July 16, 2012, in Geneva, Switzerland. The Library Copyright Alliance (LCA), was represented by international copyright advocate and librarian, Lori Driscoll, who carried the message that copyright exceptions for libraries ensure a vibrant arena for the creation and use of creative works as well as the advancement of learning.

### Library Copyright Alliance Files Second Amicus Brief in Authors Guild v. HathiTrust

On July 6, 2012, members of the Library Copyright Alliance, together with the Electronic Frontier Foundation, filed a friend of the court brief (PDF) in Authors Guild v. HathiTrust, urging a federal court to find that the fair use doctrine permitted the creation of a valuable digital library. The brief argues four main points: that the HathiTrust Digital Library (HDL) is serving the public interest, that its tremendous public benefit tilts the analysis firmly in favor of fair use, that a legislative "fix" is both unnecessary and unworkable, and that the plaintiffs helped foster public reliance on the HathiTrust project, which the public should not be deprived of now. In their lawsuit, the Authors Guild, together with a few other author groups and individual authors, propose an extremely narrow view of the rights of libraries to engage in preservation and other core library functions. In their motion for judgment on the pleadings, the plaintiffs have asked the federal court to "mothball" HDL until Congress takes action. LCA members have filed in this case to defend the rights of all libraries, as well as the extraordinary value of the HathiTrust collection. This amicus brief follows a previous (PDF) one submitted by members of the LCA on April 20, 2012.

### Library Associations, EFF File Friend of the Court Brief in Authors Guild v. Google, Inc.

On August 1, 2012, members of the Library Copyright Alliance (LCA), including the American Library Association, Association of Research Libraries and Association of College and Research Libraries, together with the Electronic Frontier Foundation (EFF), filed a friend of the court brief (PDF) in Authors Guild v. Google, Inc., a lawsuit in which authors allege that Google violated copyright by scanning books to create Google Book Search (GBS), a search tool similar to its Internet search engine. The LCA/EFF brief defends GBS as permissible under the doctrine of fair use, a flexible right that allows copying without payment or permission where the public benefit strongly outweighs the harm to individual rightsholders.

### Funding for School Libraries Included in LHHS Subcommittee's Appropriations Bill

The American Library Association applauds the efforts of the Senate Labor, Health and Human Services (LHHS), and Education Appropriations Subcommittee on including funding for libraries at this week's markup. The bill includes \$30 million for the Innovative Approaches to Literacy (IAL), which is a \$400,000 increase over FY 2012. By law, a minimum of half of the funds under this program (\$14.5 million) must go to school libraries in the neediest school districts as a competitive grant. This bill contains funding for the Institute of Museum and Library Services (IMLS) including the Library Services and Technology Act (LSTA) grants, as well as federal funding for school libraries. This bill (which has not been filed and does not yet have a bill number) was approved by the Committee on a 16-14 party line vote. Republicans opposed this bill largely over objections to the funding for the Affordable Care Act under the Department of Health and Human Services which is also contained in this bill.

### Office of Government Relations Host Webinars

The ALA Washington Office hosted several webinars for library advocates over the past few months. On June 13, 2012, the Washington Office hosted the webinar *Using D.C. Insider Secrets to Save Your Library*, where participants learned 10 tactics to increase their library's perceived value and demonstrate why libraries are one of the best investments around. Stephanie Vance, advocacy guru, and author of *The Influence Game: 50 Insider Tactics from the Washington D.C. Lobbying World that Will Get You to Yes* moderated the discussion. In July, the Office hosted "They've Got to See it to Believe It: Getting Decision Makers Into Your Library." The webinar focused on teaching participants about the secret strategies for getting decision makers in the door — and eventually agreeing with you.

### Obama Nominates Former ALA President Camila A. Alire to Administration Post

In June, President Barack Obama nominated Camila A. Alire, Dean Emerita of both the University of New Mexico and Colorado State University, to the National Council on the Humanities. The Senate must confirm Alire's nomination before she can begin her advisory post. As a National Council on the Humanities Member, Alire will join the board of twenty-six distinguished private citizens appointed by the President and confirmed by the Senate in advising the chairman of the National Endowment for the Humanities. Alire served as the President of the American Library Association from 2009 to 2010.

### CRS Resolution Introduced in the House

In July, advances were made in improving transparency in the federal government. Reps. Mike Quigley (IL-5) and Leonard Lance (NJ-07) introduced the Congressional Research Service Electronic Accessibility Resolution of 2012 (House Resolution 727), a resolution that creates a publicly available database of Congressional Research Service (CRS) reports and would thereby "enhance our democracy to provide citizens with access to unbiased and accurate CRS documents on legislation and other critical issues before Congress." This bipartisan resolution would provide public access to all CRS reports that do not contain confidential information (in some cases redactions could be made to allow portions of reports to be released). The resolution would provide access to those who fund this research—the public. The American Library Association commends Reps. Quigley and Lance, as well as the resolution's co-

sponsors; Reps. Jim Cooper (TN-5), Timothy V. Johnson (IL-15) and Adam B. Schiff (CA-29), for taking this important step to increasing transparency and improving access to publicly funded government information. The ALA strongly supports this resolution and will work towards its passage.

#### Department of Education Announces Federal School Literacy Grants

The filing period for the Innovative Approaches to Literacy Program (IAL) school literacy grants is now closed, the Department of Education announced. OGR encouraged school librarians to apply for the program grants, which can range from \$150,000–750,000. At least 50 percent of the \$28.6 million is designated for school librarians. The deadline to apply for the grant funding was August 10, 2012. The literacy grant program is designed to support innovative literacy programs for young children, increase student achievement by using school libraries and motivate older children to read. According to the Department of Education, the grants are to be used to “develop and improve literacy skills for children and students from birth through 12th grade within the attendance boundaries of high-need local educational agencies.”

#### U.S. House Passes Legislation to Bypass Some Confirmation for Presidential Appointments

The U.S. House of Representatives passed S. 679 – the Presidential Appointment Efficiency and Streaming Act of 2011. The U.S. Senate previously passed the legislation on June 29, 2011, by a vote of 79-20. The purpose of this legislation is to reduce the number of presidential appointments that the Senate must confirm thereby improving the efficiency of confirming a selected 220 executive branch positions. Currently there are approximately 1,400 executive branch positions that require a Senate confirmation. Included in the 220 executive branch positions that this legislation eliminates from senate confirmation are the 20 members of the National Museum and Library Services Board. This action may affect the current 8 nominees that have already been nominated for the National Museum and Library Services Board if they are not confirmed by the time this bill goes into effect.

#### Senate Ends Cybersecurity Act of 2012 Debate

In August, the U.S. Senate took a cloture vote to end debate on S.3414, the Cybersecurity Act of 2012. The vote was recorded as 52-46 meaning the 60 votes necessary to advance the bill were not received. This vote signals that the bill will likely not be taken up this year. The ALA Washington Office used its Mobile Commons text messaging advocacy service to urge supporters to contact their legislators to oppose the bill. The ALA thanks all of those who contacted their senators on this important issue. The fight to protect privacy is far from over though. ## OITP Releases Backgrounder on “Libraries, Patrons, and E-books”

As part of the ALA Office for Information Technology Policy’s work with the Digital Content and Libraries Working Group, several member leaders have requested that the ALA develop and distribute communications resources that will support local libraries around digital content issues. OITP released the first of these documents, a [backgrounder](#) that shares some highlights from the newest Pew Research Center report on “Libraries, Patrons, and E-books,” along with some possible messaging and local angles for leveraging this new research with local media and decision makers. Among the report’s key findings referenced in the backgrounder:

- 12% of e-book readers have borrowed an e-book from their library
- 62% of people don’t know they can borrow e-books from their library
- 69% of people report the library is important to them and their family
- Many people would like to learn more about borrowing e-books

## What is DRM and What Does It Mean for Your Library?

In an effort to help the library community better understand and adapt to the growth of digital content, ALA has released a [tip sheet](#) that provides background on digital rights management (DRM)—systems used by producers, publishers and vendors to embed controls on what users can do with electronic files, such as e-books, DVD films, and other media. Library community members, librarians and supporters are encouraged to use the tip sheet to provide additional information for interested parties. Librarians are also encouraged to keep the guide at the front desk of their libraries to spark conversations with library patrons or simply answer any questions they may have about DRM. The ALA Digital Content & Libraries Working Group created the tip sheet.

## ALA Advocates for Library Broadband Funding

The American Library Association submitted comments to the Federal Communications Commission (FCC) on its Further Notice of Proposed Rulemaking (FNPRM) on the reform of the Universal Service Fund (USF) contribution mechanism. The FNPRM is part of the Commission’s effort to modernize universal service programs—including the E-rate program—so that they can efficiently bring the benefits of 21st century broadband to the public across the

country. The ALA advocated for the Commission to ensure the stability of the USF as it addresses contribution reform such that the necessary reforms are not disruptive to individual programs. In particular, the E-rate program depends on the fund's stability in order for libraries and schools to provide Internet-enabled services to the public. Demand on the fund continues to climb as libraries include more programs and services that demand high-capacity broadband connections, such as video conferencing and mobile computer labs.

#### ALA Copyright Activist Honored at the World Library and Information Congress

The International Federation of Library Associations and Institutions (IFLA) honored longtime library advocate Winston Tabb at the World Library and Information Congress, which took place in August in Helsinki, Finland. Tabb, who is the Dean of Libraries and Museums at Johns Hopkins University, received the Honorary Fellowship—the IFLA's highest honor—for his 20 years of service for bringing light to the roles of libraries in international copyright discussions. The honorary fellowship honors persons who have achieved prolonged and distinguished service to IFLA. Tabb is well known for his work on the IFLA Committee on Copyright and other Legal Matters and as an IFLA representative to the World Intellectual Property Organization. The American Library Association recently honored Tabb with the L. Ray Patterson Copyright Award during the 2012 American Library Association Annual Conference in Anaheim in June 2012. The Patterson Award recognizes the contributions of individuals or groups that pursue and support the Constitutional purpose of the U.S. Copyright Law, fair use and the public domain.

### **American Association of School Librarians (AASL)**

#### The Power of Data

AASL has released a new publication focused on increasing a school librarian's ability to analyze and articulate data sets. "The Power of Data: An Introduction to Using Local, State,

### Publishing Review Task Group Submits Final Report

After a year of deliberation, the ALCTS Publishing Review Task Force submitted its final report to the ALCTS Board of Directors this past July. The preliminary report was discussed in detail at the ALCTS Board meeting at Annual Conference in Anaheim. The report takes a broad look at current and future ALCTS publishing activities including a mission statement, recommendations on invigorating the ALCTS publishing program, the structure and process of publishing, and new directions for the ALCTS newsletter. The ALCTS Board and Executive Committee will continue discussing the recommendations in order to determine how best to implement them.

### ALCTS and LITA Form Metadata Standards Committee

The ALCTS/LITA Metadata Standards Committee will play a leadership role in the creation and development of metadata standards for bibliographic information. The Committee will review and evaluate proposed standards; recommend approval of standards in conformity with ALA policy; establish a mechanism for the continuing review of standards (including the monitoring of further development); provide commentary on the content of various implementations of standards to concerned agencies; and maintain liaison with concerned units within ALA and relevant outside agencies. The Metadata Standards Committee will begin its work at the

Midwinter Meeting of the American Library Association, January 2013. While composition of the committee is still under discussion, membership will include equal numbers of voting members appointed by ALCTS and LITA and a voting liaison member appointed by RUSA. The committee will actively seek input from many groups and communities of practice in its work.

#### ALCTS/LITA/RUSA MARBI Committee to Disband in 2013

Having formed the new committee (above) to spearhead participation in developing a wide range of applicable metadata standards, the three ALA divisions have also voted to disband the ALCTS/LITA/RUSA Machine-Readable Bibliographic Information (MARBI) Committee, as of June 30, 2013.

#### Two New Advocacy Groups to be Created this Fall

After receiving a report from the Advocacy Task Force at the Annual Conference, the ALCTS Board agreed to create two advocacy groups to explore both internal and external advocacy initiatives. These groups will be constituted this fall. The role ALCTS should play as an ongoing contributor to advocacy efforts outside of the association will be the focus of the new advocacy committee. The new advocacy task group will focus on advocacy for ALCTS areas within the library.

One addition to content is more frequent excerpts from ALA Editions books, offering topics that are timely, well-researched, and offer information to members that they want. Such excerpts also encourage people to check out the books themselves. *Joint Libraries* and *Working Part-Time During Retirement* were featured in recent issues. The latter quoted members of the newly formed Retired Members Roundtable in a sidebar. *American Libraries* staff are also working closely with ALA Conference Services to ensure that conference-related coverage is timely, useful, and engaging.

### Salaries for Librarians Flat in 2012

According to results of the 2012 ALA-APA Salary Survey: Librarian – Public and Academic, with a less than 1 percent increase, salaries for librarians are basically flat. Survey responses from public and academic libraries in all 50 states and the District of Columbia indicate that salaries range from a low of \$22,000 in public libraries to a high of more than \$258,000, with the highest salary earners being library directors in university libraries. The Salary Survey shows aggregated data from 11,315 individual salaries of librarians with an ALA-accredited Master's degree from 618 libraries by region and state. Data is shown for public libraries serving populations under 10,000 to more than 500,000, as well as for academic libraries at community colleges, four-year colleges and university libraries, including Association of Research Libraries.

### 2012 ALA-APA Salary Survey: Librarian – Public and Academic

The information included in the newly-released 2012 Survey is useful for academic and public library directors and human resources staff for hiring and promotions considerations. It is also valuable for librarians seeking employment or considering moving to various locations across the country. The survey report summarizes salaries paid to staff in six position categories: directors/deans, associate/assistant directors, department heads, managers of support staff, librarians who do not supervise and beginning librarians.
