Center for the Future of Libraries

The American Library Association (ALA) has been awarded a Librarians for the 21st Century Grant from the Institute of Museum and Library Services (IMLS) to establish an ALA Center for the Future of Libraries. The goal of the project will be to provide library planners and community leaders with information resources and tools that will help them better understand the trends reshaping their libraries and communities and help them incorporate foresight into their planning processes. The \$50,000 planning grant project will help ALA develop a Center for the Future of Libraries website; establish a “futures” discussion group and blog; present interactive programming at the ALA Midwinter Meeting and Annual Conference and convene a summit of thought leaders to help shape the future direction of the center. In creating the Center for the Future of Libraries, ALA will also collaborate with the American Alliance of Museums, which established a Center for the Future of Museums in 2008. The Center will help public, academic and school communities build connections with experts and innovative thinkers in other fields who can help libraries better understand and meet the challenges of the future.

Declaration for the Right to Libraries Initiative

With assistance from the ALA's Information Technology and Telecommunication Services (ITTS) department, the online declaration was recently launched. ALA Launches “Authors for Library E-books” Campaign

In June, ALA announced the launch of “[Authors for Library E-books](#),” a new initiative that asks authors to stand with libraries in their quest for equitable access to e-books. Bestselling authors Cory Doctorow, Ursula K. Le Guin and Jodi Picoult are helping kick off the campaign. The campaign represents an extension of ALA's advocacy strategy to ensure all people have access to the world's knowledge and literature through our nation's libraries—regardless of format. Developed by the ALA's [Digital Content & Libraries Working Group](#), the campaign encourages authors to sign on to a statement of shared values, to discuss the issue with their publishers,

and raise awareness of their concerns through their websites, social media and other communications channels.

ALA Leadership Institute

Forty future library leaders participated in the American Library Association's first Leadership Institute on August 12-15, 2013. Led by ALA Immediate Past President Maureen Sullivan and ACRL Content Strategist Kathryn Deiss, the four day curriculum included leading in turbulent times, interpersonal competence, power and influence, the art of convening groups and creating a culture of inclusion, innovation, and transformation. The program is intended to allow participants to return to their institution with greater self-awareness and self-confidence, equipped with better skills for leading, coaching, collaborating, and engaging within their organizations and in their communities, and to be better leaders, prepared to identify, develop, and implement solutions which will benefit all stakeholders. Participants will also have the opportunity to form a vibrant learning community and network, which is an essential element of effective leadership development.

Banned Books Week

Banned Books Week 2013 took place September 22-28, 2013. This year's observance marks 31 years of ALA's celebration of the freedom to read and received wide attention in the press and in social media [see *the PIO report below*]. Libraries and bookstores hosted special events and exhibits on the power of literature and the harms of censorship, and ALA, along with its Banned Books Week co-sponsors, hosted the third annual Virtual Read Out. The Virtual Read-Out was held on YouTube [<http://tinyurl.com/bbwvro13>], where participants posted videos of themselves reading from their favorite banned books. Past participants have included highly acclaimed and/or frequently challenged authors such as Judy Blume, Chris Crutcher, Whoopi Goldberg, Lauren Myracle and many others. In 2012, OIF recorded 464 reported attempts to remove or restrict materials from schools and libraries. The number one most challenged book for 2012 is Dav Pilkey's *Captain Underpants*.

Andrew Carnegie Medals for Excellence in Fiction and Nonfiction Awards

More than 400 people celebrated the presentations of the second ever Andrew Carnegie Medals for Excellence in Fiction and Nonfiction at the Awards Presentation during the Annual Conference in Chicago. Richard Ford's *Canada* received the medal for fiction, and Timothy Egan's *Short Nights of the Shadow Catcher: The Epic Life and Immortal Photographs of Edward Curtis* received the medal for nonfiction. Both authors were present to receive their medals and \$5,000 prizes. All six finalists (Richard Ford, Timothy Egan, David Quammen, Jill Lepore, Junot Diaz, and Louise Erdrich) offered touching speeches that honored libraries and thanked librarians. Media and social media coverage was broad and enthusiastic again this year; media outreach activities resulted in more than 1,800 mentions/articles, a circulation rate of more than 820 million and a publicity value of more than \$250,000. Placements were secured with mainstream national and international media and trade publications including the Associated Press (AP), BBC, *Publishers Weekly*, *Huffington Post*, *Salon.com*, *Los Angeles Times* and many other top-tier publications. *The New York Times* ran a full-page print ad in the July 1 Arts section. More than 400,000 Web placements were captured via Google search. The awards, co-sponsored and administered annually by *Booklist* magazine and the Reference and User

Services Association (RUSA), are funded through a grant from Carnegie Corporation of New York. They were established in 2012 to recognize the best titles in fiction and nonfiction for adult readers published in the U.S. in the previous year and serve as a guide to help adults select quality reading material. The highly rated ALA online job board and career resources hub, a shared project among *American Libraries*, the Association of College and Research Libraries (ACRL)'s *C&RL News*, and the Office for Human Resource Development and Recruitment (HRDR), has seen online classified job ads achieve new heights in its seventh year of operation. Having recovered fully from the impact of the recession, ALA JobLIST seems to be trending toward continued growth at a steady rate. Reference Transaction Statistics for 2013

Reference transaction statistics for the 2013 fiscal year just ended: 3,174 queries answered, overwhelmingly by email (61%).

Membership Development

Membership

As of July 31, 2013, total ALA membership was 56,858. This is 1.85% less than July 2012. Two divisions and nine round tables had membership increases compared to July 2012. A special promotion to encourage lapsed small/very small libraries to rejoin launched in April and ended in June.

Office for Diversity (OFD)

8th National Conference of African American Librarians

In early August, OLOS Director Michelle Harrell Washington, attended and exhibited at the 8th National Conference of African American Librarians. This was yet another opportunity to promote Diversity/OLOS, ALA overall, and also to promote the Declaration for the Right to Libraries. Signatures were collected on two Declaration sheets during the Conference, and staff plan to follow up with those who are interested in promoting the Declaration in their library communities.

Office for Government Relations (OGR)

Library Services Impacted by Government Shutdown

From October 1st to October 17th, 2013, the U.S. government shut down after Congress failed to compromise on a continuing resolution to fund the government. While the ALA Washington Office remained up and running, the shutdown had a noticeable impact on library services across the country. The Institute of Museum and Library Services (IMLS) was closed and was unable to disperse grants and funds to libraries as part of the Library Services and Technology Act. U.S. Census websites and collection surveys were unavailable, and the Government Printing Office had been shut down. Finally, the Library of Congress was closed to the public and researchers for the duration of the shutdown.

OGR Welcomes the New Public Printer of the United States

Jessica McGilvray was pleased to represent the Office of Government Relations at the swearing in ceremony of Davita Vance-Cooks on August 21. Vance-Cooks is the 27th Public Printer of the United States Government Printing Office (GPO) and the first woman to serve in this position. She was confirmed unanimously by the Senate on August 2 and was proudly sworn in later that month. The ALA looks forward to working with the GPO and the Public Printer in the coming years.

OGR Involved with New Project on Seniors and Technology

OGR cosponsored and participated in a pilot workshop with Senior Service America, Inc., Montgomery County Public Libraries, the Benton Foundation as well as officials from both the U.S. Department of Labor (DOL) and the Maryland Workforce Corporation. This is part of ALA's efforts to assure that libraries are recognized and can get funding for workforce investment programs. The pilot workshop is intended to be replicated in a number of other states and support senior job hunters by offering digital literacy training through libraries and cooperative activities with various state and local government employment services.

ALA President Speaks on National Security Agency Leak; Organization Launches Privacy Toolkit

In July, ALA launched "[ALA Liberty](#)," a new website that contains tools libraries can use to host educational sessions and public forums that help Americans understand their First and Fourth Amendment rights. The launch of [ALA Liberty](#) comes as a response to revelations that the U.S. government obtained vast amounts of data on the activities of millions of innocent Americans. The website contains guides and tip sheets for libraries interested in informing members of the public about their civil liberties. The tools provide an overview of the deliberative process and outline ways that the public can demand government oversight and transparency from legislators.

ALA Joins Apple, Microsoft in Demanding Transparency in Government Surveillance

In July, the American Library Association joined an unprecedented coalition of Internet companies and advocates to [deliver a letter](#) to the U.S. government demanding greater transparency around national security-related surveillance of Internet and telephone communications. Key civil liberties organizations and major companies such as Apple, Facebook and Twitter, joined in the effort with dozens of other companies and organizations, both large and small. [WeNeedToKnow](#), the newly launched petition directed at the White House invites the public to contribute to the call for greater transparency around government surveillance.

IMLS, ALA Detail Affordable Care Act Resources for Library Staff

The Institute of Museum and Library Services (IMLS) and ALA recently announced information resources for libraries to use to assist patrons about the Affordable Care Act. OCLC's library program WebJunction will provide online educational webinars, tip sheets, and other resources to help library staff members respond to increased patron information needs related to the new health insurance marketplace. Office for Human Resource Development and Recruitment (HRDR)

HRDR Turns 40

The [Office for Human Resource Development and Recruitment \(HRDR\)](#) formerly the Office for Library Personnel Resources (OLPR) celebrated its 40th Anniversary on Saturday, June 29, 2013 in the ALA JobLIST Placement Center. President-Elect Courtney L. Young brought greetings and was on hand for the cake cutting.

ALA JobLIST Placement Center

The [ALA JobLIST Placement Center](#) had a very successful conference in Chicago. Over 50 individuals had career counseling sessions while 538 people attended the eight career development workshops. Employers representing 21 organizations participated in the Open House that 125 individuals attended. 207 individuals had their resumes reviewed by volunteers from the [New Members Round Table \(NMRT\)](#), and 12 organizations exhibited as recruitment vendors.

Office for Information Technology Policy (OITP)

Digital Content Working Group Prepares for Virtual Town Hall

On October 23, 2013, the ALA Digital Content Working Group (DCWG) will host its Virtual Town Hall on Ebooks, an interactive online session that will take place from 11 a.m. – noon (Central). Participants will have the opportunity to join ALA President Barbara Stripling, Immediate Past President Maureen Sullivan and the leadership of the ALA’s Digital Content Working Group to learn about ALA ebook activities, plans and future directions. American Library Association Leads Libraries on E-rate Reform

This summer, President Obama announced the ConnectED initiative, which aims to connect America’s students to high-capacity broadband and high-speed wireless. In September, ALA asked the Federal Communications Commission to accelerate deployment of the high-capacity broadband needed to serve students and learners of all ages through our nation’s libraries and schools. ALA calls for new E-rate funding to jumpstart and sustain high-capacity broadband connections that support digital learning and economic development through libraries and schools, referred to as “ConnectUS.” ALA leadership discussed E-rate in October at the Schools, Libraries and Health Broadband Coalition meeting in Washington, D.C.

OITP Talks Ebooks with Publishers in New York

In late September, Barbara Stripling led an ALA delegation to New York to meet with publishers and others in the publishing ecosystem; the delegation includes Maureen Sullivan, Keith Michael Fiels, DCWG Co-chair Robert Wolven and Alan S. Inouye. ALA delegation members met with executives at Penguin Random House and Simon & Schuster, the Association of American Publishers and the American Booksellers Association. ALA Submits Comments to the FCC Opposing the E-reader Accessibility Exemption

ALA’s Office for Information Technology Policy submitted comments to the FCC in response to a petition from the E-reader Coalition Petition of Class Waiver of Commission’s rules for Access to Advanced Communications and Services for People with Disabilities. The E-reader Coalition—Amazon, Sony and Kobo— assert that their e-readers were manufactured for the sole purpose of reading text, therefore they should not be required to comply with FCC regulations that e-readers be accessible. The E-reader Coalition suggests that e-readers are a different class of product. ALA argues that the E-reader Coalition exemption would be discriminatory.

Maine State Librarian Touts E-Rate Successes at Congressional Hearing

In July, Maine State Librarian, Linda Lord, called for a “proactive vision for meeting the educational and learning needs of our communities for the next 15 years and beyond” at a hearing of the U.S. Senate Committee on Commerce, Science and Transportation. Representing our nation’s 16,400 public libraries, Lord touted the success of the E-rate program in helping connect nearly 100 percent of libraries to serve more than 30 million people every week. The hearing came before the Federal Communications Commission considered a Notice of Proposed Rulemaking to modernize the E-rate program to support high-speed broadband for digital learning technologies and ensure all students, educators and library patrons have the tools they need to succeed in the 21st century. With demand already double the available E-rate funding, ALA will submit comments to the FCC on raising the funding cap for the E-rate program.

Google, ALA Host Webinar: Revisiting CIPA 10 Years Later

In July, the American Library Association and Google, Inc. hosted a national symposium where library, education, technology, legal and policy experts considered the impact of the Children’s Internet Protection Act (CIPA) on access to electronic information. Participants joined a wide range of experts to discuss insights looking at legal, ethical, and political implications of how the CIPA requirements have been implemented in the past 10 years. “Revisiting the Children’s Internet Protection Act: 10 Years Later” was part of the Office for Information Technology Policy and Office for Intellectual Freedom’s larger project on CIPA and access to information, made possible through support of Google, Inc. A white paper will be released this fall.

Library Copyright Alliance Hails WIPO for Landmark Victory for the Blind

In June, the Library Copyright Alliance applauded the World Intellectual Property Organization (WIPO) for finalizing the Treaty for the Blind, a treaty that will allow nations to share or make accessible copies for the print disabled in other countries, who more often than not, have little access to reading materials. The Treaty for the Blind creates a copyright exception and makes it legal to share accessible print copies with other nations. Before the landmark decision, antiquated international copyright laws made it difficult for developing nations—where 90 percent of the world’s 285 million blind live—to convert print materials into Braille books, audio recordings, or accessible digital files. As a result of the treaty, the diversity of content available to the blind will increase dramatically around the world. Office for Intellectual Freedom (OIF)

IFLA / FAIFE Report

The August 17-23 International Federation of Library Associations (IFLA) Congress in Singapore echoed concerns of June's ALA Annual Conference—questions and deep concerns about privacy and surveillance, in the wake of the leaks about National Security Agency (NSA) surveillance of telephone calls, which of course included international communications. Several countries have expressed their interest in joining with ALA in creating awareness of how these serious invasions of privacy affect libraries. CILIP (the UK's Chartered Institute of Library and Information Professionals) met with an ALA representative to determine next steps in collaboration. Other interested parties include Finland and Germany, and there are sure to be more. IFLA's FAIFE Committee (Free Access to Information and Freedom of Expression) is planning a meeting of interested parties in London later this fall. FAIFE is also drafting a policy on Privacy and Surveillance to be ready for the IFLA Executive Board meeting in December. Association of Rural and Small Libraries Conference in Omaha, NE

During October, Michelle Harrell Washington exhibited at the Association of Rural and Small Libraries Conference in Omaha, NE. Additionally, both John Amundsen and Michelle exhibited at the Association of Bookmobile and Outreach Services Conference in Baton Rouge, where they also presented the session 'Literacy for All' during the conference on Wednesday afternoon, and again on Thursday morning. During this session highlighting OLOS' toolkits, the focus was on the Literacy for All toolkit, developed in 2012. Both presentations of the topic generated lively discussion and very positive feedback about how valuable the resources that were shared will be to the work that people are doing in terms of literacy services at their libraries.

Annual Conference Provides Opportunities for Member Interaction

The Office for Literacy and Outreach Services and the Office for Diversity were provided with excellent opportunities at the Annual Conference to offer worthwhile programs from the roundtables and committees, as well as opportunities to engage in invigorating conversations regarding member involvement and partnerships, including the Veterans Administration's initiative to push out information to librarians and library workers that can be shared with library users who are veterans and at risk (homeless, mental health/suicide).

Association for Tribal Archives, Libraries and Museums Conference

Just prior to the Annual Conference, OLOS Director Michelle Harrell Washington attended and exhibited at the Association for Tribal Archives, Libraries and Museums Conference in Santa Ana Pueblo, NM. This was an excellent opportunity to engage with conference attendees and talk with them about Diversity/OLOS and ALA overall.

Ardmore (Oklahoma) Literacy Initiative

In mid August, a new initiative being spearheaded by the Dollar General Literacy Foundation, the Ardmore (Oklahoma) Literacy Initiative, took Michelle Harrell Washington to Ardmore, OK. This initiative is just getting off the ground, so there will be more to come, but this on-site visit provided an excellent opportunity to meet and engage in productive conversation regarding the initiative with its local and national partners. OLOS is working with the Ardmore Public Library and incorporating some of the takeaway lessons from the Dollar General-funded American Dream Starts @ your library Project.

Office for Research and Statistics (ORS)

Public Library Reseqr4ch Clearinghouse

The Bill & Melinda Gates Foundation (PLFTAS) Grant, 2009-2012 received a second extension to December 2013. The extension provides funding to address action items identified during the Invitational Seminar for Public Library Researchers that took place May 16-17 at ALA headquarters in Chicago. ORS staff will develop a web-based clearinghouse for public library research and data collection efforts. The site will include supports for finding, interpreting and using data, and links to grant opportunities.

IMLS National Leadership Grant

ORS and the University of Maryland College Park have launched the Digital Inclusion Survey for Public Libraries. An IMLS National Leadership Grant titled *Public Libraries as Providers of Digitally Inclusive Services and Resources: A National Survey Redefined* funds the survey. Partners include OITP and the International City/County Management Association (ICMA).

CIPA Forum

Kathy Rosa participated in the *Revisiting Children's Internet Protection Act (CIPA) Forum* at the Google office in Washington, D.C., July 29-30. The symposium provided the opportunity to review the previous 10 years of CIPA implementation and review the efficacy of the law as a solution to protecting young people from harmful content on the internet. The symposium is one component of a larger project coordinated by the Office for Information Technology Policy and the Office for Intellectual Freedom and will inform a white paper that will be published in the fall.

IMLS Library Statistics Working Group (LSWG)

Kathy Rosa participated in the IMLS Library Statistics Working Group (LSWG) biannual meeting held on Thursday, July 11 in Washington, D.C. The LSWG represents State Data Coordinators and other public library stakeholders and advises IMLS on the conduct of national public library and state library data collections. The LSWG is active in the development of the Public Library Survey data elements, software, and training.

Presentations

Kathy Rosa was a panel speaker at the 2013 Annual Conference (AC13) for the session titled *Measuring Up: Developing New Metrics for Assessing Library Performance*, a session selected as an Editor's Pick by *Library Journal*. Rachel Fleming May and Anne Houston joined Rosa in this Committee on Research and Statistics (CORS)-sponsored session that was attended by over 300 people. Kathy also delivered two presentations during the SDLA—NDLA—MPLA (South Dakota – North Dakota – Mountain Plains Library Associations) TriConference. The conference was held in Sioux Falls on September 25 – 27. The programs were *Library Management and the Digital Shift* and *Amplify Library Value: Using Data for Results*.

Worldwide Virtual Conference

Kathy Rosa is delivering a session as well as serving on the Advisory Board for the Library 2.013 Worldwide Virtual Conference to be held October 18 – 19. Rosa's presentation is titled *ALA Presents—Public Libraries: Communicating Impact with Stats and Stories*.

Public Information Office (PIO)

Disney Princess Belle Appears in September Celebration of Library Card Sign up Month

As part of the September celebration of Library Card Sign up Month, Disney Princess Belle the fictional main character who appears in Walt Disney Picture's popular animated film, *Beauty and the Beast*, joined the American Association of School Librarians (AASL) member Amber Claflin in an event at Grapeland Elementary School in the Anaheim, CA, area. Disney Book Group, working with the ALA Campaign for America's Libraries, sponsored the event, which featured Belle reading to and interacting with students.

Free Customized PSAs of Luol Deng, Honorary Chair of Library Card Sign up Month

This year, Chicago Bulls player and all-star, Luol Deng, was the Honorary Chair of Library Card Sign up Month and appeared in print and web based public service announcements (PSAs) that libraries can have customized at no cost. A native of the Sudan, Deng has won the NBA's sportsmanship award for the player who best exemplifies ethical behavior, fair play and integrity on the court. In 2008, Deng was honored with the United Nations Refugee Agency's Humanitarian of the Year Award for his efforts to bring education and sports to millions of displaced children.

Publicity for Banned Books Week

PIO worked with the ALA's Office for Intellectual Freedom to secure publicity for Banned Books Week, September 22 - 28. PIO has secured national and international print and radio interviews for ALA and OIF leadership with the [Huffington Post](#), [CNN.Com](#), [The Guardian \(UK\)](#), [BBC Persia](#) and [Sydney Educational Broadcasting](#). Banned Books Week articles/mentions appeared on news websites including: [UPI](#), [ABC News](#), [MSNBC](#), [Entertainment Weekly](#), [Market Place](#), [Parade](#), [Washington Post](#), [Forbes](#), [Christian Science Monitor](#), and [Boing Boing](#). From September 1 – October 7, more than 2,500 articles were captured by ALA's monitoring software CisionPoint. As of October 7, media outreach efforts produced a snapshot circulation rate of more than 1.3 billion and a publicity value snapshot of more than \$700,000. PIO also crafted a series of press materials, including [PSAs](#), a [Web press kit](#), calendar notice, press release, media plan and talking points.

Public Programs Office (PPO)

The Promise... Tools Support Library-Led Community Engagement and Innovation

Attendees at the recent 2013 ALA Annual Conference in Chicago got a first look at an array of tools produced to assist libraries with community engagement and innovation as part of *The Promise of Libraries Transforming Communities*. ALA has partnered with the Harwood Institute for Public Innovation for this multiphase initiative to develop a sustainable national plan to advance community engagement and innovation and transform the role of libraries in their communities. These Harwood Institute tools, shared as part of *The Promise of Libraries Transforming Communities* project, include: Turn Outward, Aspirations, Intentionality, Sustaining Yourself, and How Librarians and Libraries Can Lead Community Conversations for Change. Year-long Public Innovation Training Opportunity

The Promise of Libraries Transforming Communities initiative is the first step in building a sustainable and scalable national plan for library-led community engagement. Continuing the collaboration between the Harwood Institute and the American Library Association on *The Promise of Libraries Transforming Communities* initiative, a three-day Harwood Institute Public Innovators Lab, designed especially for libraries, kicks off a year of coaching and webinar

support. The three-day immersion in the Harwood practice, October 28-30, 2013, at the District of Columbia Public Library Martin Luther King Jr. Memorial Library, will be followed by one year of scheduled coaching support for library teams from a Harwood certified coach, plus six live webinars to support and reinforce the learning from the Lab. "Dust, Drought, and Dreams Gone Dry," Traveling Exhibition

The ALA Public Programs Office (PPO), in partnership with the Oklahoma State University (OSU) Library and the Mount Holyoke College (MHC) Library, is in the process of selecting public, academic and special library sites for *Dust, Drought, and Dreams Gone Dry: A Traveling Exhibition and Public Programs for Libraries about the Dust Bowl*. The project features a traveling exhibition and a series of programs designed to help public audiences engage in discussions about the human and ecological consequences of one of America's most disastrous environmental experiences. The project draws upon OSU's "Women in the Dust Bowl," online oral histories of Dust Bowl survivors, and the MHC's Caroline Henderson papers—letters, essays and articles by a woman who farmed throughout the Dust Bowl period. Ken Burns' film, "The Dust Bowl," is also an inspiration for the project. Twenty-five sites will be selected to present the exhibition and associated public programs in their communities for a period of six weeks. The tour and programs will begin in June 2014 and continue through December 2015. The project is made possible in part by the National Endowment for the Humanities: Exploring the Human Endeavor.

"Changing America: The Emancipation Proclamation, 1863 and the March on Washington, 1963," Traveling Exhibition Opportunity

The ALA Public Programs Office (PPO), in collaboration with the Smithsonian's National Museum of African American History and Culture (NMAAHC) and National Museum of American History (NMAH), invites applications from public, academic and special libraries, small museums, and historical societies for the traveling exhibition *Changing America: The Emancipation Proclamation, 1863 and the March on Washington, 1963*. *Changing America* will help public audiences understand and discuss the relationship between two great peoples' movements that resulted in the Emancipation Proclamation in 1863 and the March on Washington in 1963. The traveling exhibition is made possible by the National Endowment for the Humanities (NEH). [Online applications](#) must be submitted to ALA by October 21, 2013. Fifty sites will be selected to present the traveling version of the exhibition in their communities for a period of six weeks. The tour and programs will begin in January 2014 and continue through December 2017.

Planning Meeting for "U.S. Citizenship in the 21st Century" Convened in Atlanta

On October 2-3, 2013, in Atlanta, the ALA Public Programs Office and the American Bar Association co-convened the first of two planning meetings for the National Endowment for the Humanities-funded planning grant *U.S. Citizenship in the 21st Century*. The project team included scholars with expertise in jurisprudence, political science, and literature, and programming librarians from rural, suburban, and urban communities. The meeting explored possible project themes, with the group tentatively deciding to focus on Rights and

Responsibilities, Equal Citizenship, Identities and Cultural Citizenship, and Transnational Citizenship. The second and final planning meeting will be held December 12-13, 2013, in Chicago. This meeting will focus on reading material selection, program model format, and development of other supporting resources. Work products developed during this planning grant phase will be made available online as at least two, ready-to-implement library programming modules in May 2014.

PPO Proposed Collaboration with Smithsonian's National Museum of Natural History (NMNH)

The ALA Public Programs Office has partnered with the Smithsonian's National Museum of Natural History (NMNH) Human Origins Project in a proposal to the John Templeton Foundation for a traveling exhibition to public libraries entitled "What Does It Mean to Be Human: Promoting a National Conversation on Human Evolution by Touring the Smithsonian's Hall of Human Origins." Plans call for the interactive exhibition to travel to 19 sites over a three-year period. Scholars and educators from the NMNH staff will visit each site to help develop and present programs for the public about the exhibition content. The NMNH premise for the project is an inclusive one: Scientific findings, by themselves, do not inform all there is to know about the qualities that define human uniqueness and its causes and implications. If funded, the project will begin in July 2014.

PPO Proposed Collaboration with the Folger Shakespeare Library

The ALA Public Programs Office has partnered with the Folger Shakespeare Library, Washington, D.C., in an implementation proposal to the National Endowment for the Humanities for "Shakespeare and His First Folios," a project which will include a traveling exhibition and display of an original Shakespeare First Folio in every state.

Jennifer Lagarde and AASL members Shannon Miller, Joyce Valenza and Matthew Winner joined Black as nominees for the award.

Standards Task Group Submits Final Report

After a year of deliberation, the ALCTS Standards Task Force submitted its final report to the ALCTS Board of Directors at this past Annual Conference. The report's recommendations were discussed at the ALCTS Board meeting in Chicago. The report takes a broad look at current and future ALCTS standards involvement including a recommendation to establish an ALCTS Standards Committee to oversee and coordinate ALCTS involvement in standards development. ALCTS is already involved at various levels of the organization including cataloging, metadata, and NISO.

Advocacy Resources Task Force Submits Final Report

The Technical Services Advocacy Resources Task Force submitted its final report which focused on advocacy for ALCTS areas within the library. They created a collection of resources to assist ALCTS members in demonstrating and articulating the value of library functions in ALCTS' areas of coverage, historically known as technical services. The Task Force recommended that an Advocacy Resources web site be created making available resources on advocating for technical services within a library. Elements of the website would include elevator speech examples, specific information about functional areas, glossary, literature sources, and links to useful websites.

Minimum Capture Requirements Endorsed by the ALCTS Board

The ALCTS Board has endorsed "Minimum Digitization Capture Recommendations." A Task Force of the Preservation and Reformatting Section (PARS) Preservation Standards and Practices Committee was commissioned to develop minimum standards for the digital capture or reformatting of documents for preservation purposes. The Task Force was chaired by Ian Bogus of the University of Pennsylvania. The [Recommendations](#) are available on the ALCTS website. The "Minimum Digitization Capture Recommendations" were "created as a guideline for libraries digitizing content with the objective of producing a sustainable product that will not need to be re-digitized. Institutions can feel secure that if an item has been digitized at, or above, these specifications, they can depend on it to continue to be viable in the future. In some cases, institutions may want to request a digital copy to preserve themselves, further safeguarding materials by preserving them in multiple locations.

Up to 15 mini-grants will be awarded at \$2,000 each to public libraries which demonstrate a need to better address diversity within their communities through Día Family Book Club programs. In addition to awarding mini-grants, funding from this grant will also allow ALSC to create a Día Family Book Club National Curriculum that will be accessible to all.

ALSC Launches Mentoring Program

In August, ALSC launched a [new mentoring program](#). The program, which is open to members and non-members, is intended to help build a new collection of leaders in the field of library service to children. Applications were due on August 30, 2013 and over 150 children's librarians, school librarians, information professionals, and MLIS students applied to take part in this program. Members of the ALSC Membership Committee and the ALSC Managing Children's Services Committee, who administered the matching mentors and mentees, were excited and overwhelmed by the positive response to the program. 60 applicants were matched. Unsuccessful applicants will have the opportunity to re-apply in January when the second round of applications opens, and an ALA Connect Community will be available to unmatched mentees to allow another opportunity for peer networking.

ALSC Offers Student Session on Balancing Social Media

In September, ALSC hosted a student session on social media in libraries. [Balancing Social Media: How to Separate Your Library's Facebook Page From Your Own](#) was hosted by Joella Peterson, Youth Services Librarian at the South Jordan Library, part of the Salt Lake County

(UT) Library System. ALSC Student Sessions were online workshops that lasted about an hour and were led by ALSC members from across the country. Hosted by the ALSC Membership Committee, these student sessions were open to all students, ALSC members and non-members. They were offered free of charge.

Objectives of this project are to further establish and advance the valuable role of public libraries as partners in early literacy and community learning and to provide critically needed research on the impact of parent/caregiver intervention in young children's reading success. The project will use the [Every Child Ready to Read® @ your library® Second Edition \(ECRR2\)](#) as the parent education model to study. Because ECRR2 promotes a common set of goals and program content for libraries, use of this model will insure consistency in the study.

Ellen Beauregard, worked for *Booklist* for more than 30 years in a variety of roles, and was responsible for initiating and building audio coverage in the magazine and more recently online, including serving as founding editor of the e-newsletter "[Booklist Online Video Review](#)." Beauregard will continue reviewing audiobooks for *Booklist* and will remain editor of "Video Review."

Booklandia, a Seventh Free e-Newsletter

In June, [Booklist added Booklandia, a seventh, free e-newsletter](#), to its roster of popular, editor-curated offerings. Sub-titled "Where YA Books Live," this bimonthly newsletter will keep subscribers updated on trends in YA literature through a mix of original feature articles and selected *Booklist* reviews of notable YA titles, as well as offering informative, entertaining and often edgy commentary on the YA scene. With a hugely positive response to the first issue, there are high hopes for this newsletter sponsored by Amazon/Skyscape.

Booklist Events at the Annual Conference

In YA-related news, the *Booklist* Books for Youth Forum held Friday, June 28 at the ALA Annual Conference was wildly successful. Speaking to a crowd of over 400 attendees, the star-studded panel of Cory Doctorow, Lois Lowry, Patrick Ness, and Veronica Roth spoke about dystopian literature for teens. The event was moderated by Books for Youth associate editor Annie Kelley. The second-ever Andrew Carnegie Medals for Excellence award ceremony was held on Sunday, June 30, and is described in the Spotlight section of this report. The ALA Annual Conference was full of many other exciting programs and events from *Booklist* including in-booth author interviews with Printz and Odyssey winners and honorees; productive and valuable editorial board meetings; the *Booklist* reference program "Fantastic Voyage: Reference Service in an Ever-Shrinking Print Environment"; publisher meetings, and more. booklistonline.com

Booklist Webinars

Booklist's fall webinar program ramped up in September and October, covering romance, series nonfiction, new youth and YA titles, weeding, and more. The 3,000 maximum registrant cap was reached just two days after the e-blast invite went out for "What Not to Weed: Best Practices in Weeding Library Collections." An overflow page was created where people could sign up to receive the video archive, bringing the total number of sign-ups to over 5,000.

Book Links and the Common Core

Mary Napoli, Associate Professor of Reading and Children's Literature at Penn State Harrisburg, sent this comment on receiving the September 2013 *Book Links*: "The interviews with authors and the connections to the Common Core will certainly guide teachers and librarians on their journey to meet the standards, but more importantly to share the work of outstanding authors and illustrators with their readership. I know that I will be sending my students and fellow educators to this issue for inspiration."

ALA Digital Reference: RDA Toolkit

RDA Toolkit finished fiscal year 2013 on August 31 with approximately 110% increase in the number of subscribers over FY12. Renewal rates have consistently been above 80%, and the number of new accounts from consortia has seen rapid growth since June. Eblasts, webinars and [online blog posts](#) by editor James Hennelly continue to keep subscribers and others informed.
