Libraries Applaud Dismissal of Google Book Search Case

After eight years of litigation, the U.S. District Court for the Southern District of New York upheld the fair use doctrine when the court dismissed *Authors Guild v. Google*, a case that questioned the legality of Google's searchable book database. The Library Copyright Alliance—which is comprised of the American Library Association, the Association of College & Research Libraries and the Association of Research Libraries—welcomes Judge Denny Chin's decision to protect the search database that allows the public to search more than 20 million books. In his dismissal of the case, Judge Chin referenced an [amicus brief](#) submitted by the Library Copyright Alliance and enumerated the public benefits of Google Book Search by calling the project a fair use under the copyright law.

ALA Launches Policy Revolution! Initiative for Libraries

The Office for Information Technology Policy will begin work on a national public policy agenda and action plan for U.S. libraries with support from a new grant from the Bill & Melinda Gates Foundation. Nearly \$1 million in funding over three years will enable the ALA to increase library visibility and build capacity for sustained action on the national level. The three-year initiative includes three major components: establishing policy priorities, engaging decision makers and influencers to advance policy goals, and upgrading ALA policy advocacy practice and capabilities for long-term sustainability. An important activity under this capacity-building umbrella is training a cadre of library policy advocates to supplement ALA staff capacity.

Nation's Largest School Librarian Conference Educates and Inspires

Three-thousand inspired school librarians, educators, exhibitors and guests left the AASL 16th National Conference & Exhibition ready to "rise to the challenge of the profession." The largest conference dedicated solely to the needs of school librarians, AASL13 featured preconference workshops, school and educational tours, more than 140 top-quality continuing education programs, author events and more than 160 exhibiting companies. Membership Development

November Report

The ALA membership count as of October 31, 2013 was 57,404. This is 294 greater than the September 30, 2013 membership. The October 31, 2012 membership count was 57,840. Four divisions and 10 roundtables had membership increases in November, and joint ALA-Chapter student membership packages exceeded last year's count by 300.

Office for Accreditation (OA)

Committee on Accreditation (COA) Fall Meeting News

The Committee on Accreditation (COA) welcomed two new members at its fall meeting November 21-22 and made several key decisions regarding accredited status of programs and the *Standards*. Accreditation decisions included the granting of Precandidacy status to the Master of Management in Library and Information Science program at the University of Southern California and the continuation of Conditional accreditation status for the MLS program at Queens College, the City University of New York (CUNY), following an appeal of the April 2013 decision to withdraw accreditation. The Committee prepared the draft revised Standards to release for comment in December in anticipation of discussion sessions scheduled at the Association for Library and Information Science Educators (ALISE) meeting, Friday, 2:00 p.m. and the ALA Midwinter Meeting, Sunday, 4:30 p.m.

Office for Diversity (OFD)

Spectrum Scholarship Program Updates

PLA has re-established travel grants for Spectrum Scholars to attend the 2014 Conference. Spectrum Fundraising Updates

A Year End Giving campaign letter and Report on the Spectrum Presidential Initiative was mailed in November to major donors, inviting them to join the Spectrum Leadership Circle, which recognizes individual supporters who pledge \$500 or more per year, and organizations that pledge \$1000 or more per year. A year end giving appeal email is also being sent to all prior donors. The appeal seeks to raise \$8000 through individual gifts at the Spectrum Leadership Circle level, and \$2000 through other year end gifts. Spectrum Giving Back Chair, Dr. Em Claire Knowles, also invites advocates to organize Dinners for Spectrum as a fun way to raise funds and celebrate/support local Spectrum Scholars. The goal is to raise \$3000 through fundraising events. Dr. Knowles' kick-off event at Simmons College on November 14 raised \$1,755. YALSA highlighted its support of Spectrum by dedicating a Giving Tuesday spotlight to fundraising efforts to help sponsor the annual YALSA Spectrum Scholarship (see <http://yalsa.ala.org/blog/2013/12/03/giving-tuesday-support-the-spectrum-scholarship/>).

Office for Government Relations (OGR)

ALA Welcomes USA Freedom Act

ALA is rallying librarians to support the USA Freedom Act, a bill that will improve the balance between terrorism prevention and personal privacy protection. The USA FREEDOM Act would place restrictions on bulk phone and internet government surveillance, and permit companies to make public the number of Foreign Intelligence Surveillance Act (FISA) orders and National Security Letters received. The bicameral legislation would rewrite section 215 of the Patriot Act. ALA is encouraging members, library supporters and privacy advocates to tell their U.S. representatives and senators to cosponsor the Freedom Act.

ALA Opposes Harmful Federal Research Legislation

In November, legislators circulated language for a bill entitled the Frontiers in Innovation, Research, Science and Technology Act of 2013 (FIRST), a bill that would restrict public access to articles reporting on federally-funded research for up to three years after initial publication. The proposed delay is two and a half years longer than what is proposed in the bicameral and bipartisan Fair Access to Science and Technology Research Act. ALA has joined in a letter with ten other national and regional library, publishing, and advocacy organizations expressing strong opposition to the current language in FIRST.

OGR Hosts Free Webinar on Local Library Advocacy

In November, the Office of Government Relations hosted “The Fiscal Situation in Washington and How it Gives Librarians a Huge Advantage,” a webinar to educate library advocates on how to influence state and local politics. The webinar was led by OGR advocacy consultant, Stephanie Vance, who outlined the current political climate in Washington, D.C. and how advocates can use the inactivity on the federal level to their advantage at the local level. Stephanie Vance also presented findings from a recent OGR advocacy survey that generated over 1,000 responses. The information gathered in the survey will help Washington Office staff and library advocates continue to develop successful grassroots strategies.

ALA Joins Educators, Telecommunications Firms in Supporting E-rate

ALA urges the Federal Communications Commission to swiftly reform the federal E-rate program so that our nation’s learners are connected to high-capacity broadband through libraries and schools. ALA [proposes](#) two limited-term programs that build on President Obama’s ConnectED initiative—*ConnectUS* and *FINAL*. *ConnectUS* would jumpstart high-

capacity connections to libraries and schools where such broadband is not currently available. *FINAL* (Fast Internet Networks for All Libraries) is a pilot proposal for communities where high-capacity connections are available, but the library lacks the funding to realize major broadband upgrades. ALA met with the Federal Communications Commission in November to advocate for modernization proposals.

Digital Content Working Group Hosts Ebook Town Hall

Nearly 700 librarians, publishers and media representatives participated in the American Library Association's first Virtual Town Hall on Ebooks in October. Office for Intellectual Freedom (OIF)

FTRF and ALA File Brief in Lawsuit Challenging Arizona's Ethnic Studies Ban

On November 25, 2013, the Freedom to Read Foundation (FTRF) and the American Library Association joined with several other library, education, and free speech organizations in filing an amicus brief with the Ninth Circuit Court of Appeals in *Arce v. Huppenthal*, a lawsuit challenging the constitutionality of Arizona Revised Statute § 15-112(A). The brief argues that the statute, which led to the disbanding of Tucson's Mexican American Studies (MAS) program and the removal of books from Tucson high school classrooms, violates Arizona students' First Amendment rights to receive information and is unconstitutionally overbroad. Joining FTRF and ALA on the brief are the Asian/Pacific American Librarians Association, the Black Caucus of the American Library Association, REFORMA: The National Association to Promote Library & Information Services to Latinos and the Spanish Speaking, the American Booksellers Association for Free Expression, the Comic Book Legal Defense Fund, the National Association for Ethnic Studies, the National Coalition Against Censorship, and the National Council of Teachers of English.

Office for Library Advocacy (OLA)

Declaration for the Right to Libraries Signings

The Office for Library Advocacy has been involved with Declaration for the Right to Libraries signings around the country. To date, the office has gathered more than 6,000 in-person signatures, and the online declaration already has over 4,500 signatures. Thirty signings have taken place so far, with more planned around the country.

Working with Threatened Libraries

The Office for Library Advocacy continues to monitor crisis situations in libraries around the country and assist when possible. This past month, it coordinated ALA's signing onto an Amicus Brief in defense of Kentucky's class action lawsuits against Kenton and Campbell Counties. These lawsuits threaten public library funding for most Kentucky public libraries. OLA and PLA are the primary liaisons to the Miami-Dade County Library, as part of Miami Mayor Carlos A. Gimenez's Blue Ribbon Task Force on the Future of Libraries. Miami faces serious budget reductions in the coming year. OLA also facilitated a joint letter from Barbara Stripling and AASL President Gail Dickinson in opposition of the Vermont State Board of Education's proposal to change language in legislation that school librarians are optional and not mandatory. As of November 21, school librarians were added back into the staffing standards. However, a formal decision will not be reached in December.

OLA at the AASL Conference in Hartford, CT

OLA participated in the American Association of School Librarians (AASL) conference in Hartford, CT, and distributed roughly 4,000 free copies of the *100 Things Kids Will Miss if They Don't Have a School Librarian* Poster and promoted Declaration signings in school libraries. OLA collaborated with the Hartford Public Library to host a Declaration Signing at the main library in conjunction with the AASL conference.

Office for Literacy and Outreach Services (OLOS)

American Dream Starts @ your library

OLOS staff visited three current round American Dream libraries, and participated in two conferences with a poster session on the American Dream during October and November. On October 17, OLOS staff shared information on the American Dream project at the Illinois Library Association, and were joined by Esther Chase from Berwyn Public Library, one of the libraries in the current round of the American Dream project. On October 22, OLOS Communications Officer John Amundsen visited the Citizen Study Group at Berwyn Public Library to see their program firsthand. In early November, the OLOS staff visited Waukegan Public Library to get a closer look at the wide variety of programs and services being offered with the American Dream grant. On November 14, OLOS staff had the pleasure of visiting another current round American Dream library, the Pinewoods Branch of the Athens (GA) Public Library, and meeting its wonderful program staff, volunteers and students. The next day, OLOS staff were joined by Pinewoods Branch Coordinator, Aida Quinones, and Lois Strauss from Greenwood (SC) County Library (another current round library), to share information on the American Dream Starts @ your library project during a poster session at the joint SELA/SCLC conference in Greenville, SC.

Public Information Office (PIO)

Winners of the Carnegie Corporation of New York/New York Times I Love My Librarian Award

Ten librarians will be recognized for service to their communities, schools and campuses as winners of the Carnegie Corporation of New York/New York Times I Love My Librarian Award. More than 1,200 library patrons nationwide nominated librarians. The 10 award recipients will be announced Tuesday, December 17 and will receive a \$5,000 cash award. The winners will be honored at a ceremony and reception in New York, hosted by The New York Times. In their nominations, library patrons told stories of how their librarians make a difference in their communities. Nominations were open to librarians working in public, school, college, community college and university libraries. AASL Conducts National Surveys on the Branding of School Librarianship

As part of its commitment to furthering diversity in the school library profession, AASL named Ina Laguerta as its 2013 Spectrum Scholar. The Spectrum Scholarship fund is the American Library Association's national diversity and recruitment effort designed to address the specific issue of under-representation of critically needed ethnic librarians within the profession. AASL supports Spectrum Scholars through conference assistance and mentoring.

AASL Sponsors Emerging Leaders Beth Ebenstein Mulch and Jillian Rudes

AASL will sponsor two participants in the American Library Association's 2014 Emerging Leaders program. The AASL-sponsored participants will join more than 50 of their peers as the program kicks off at the 2014 ALA Midwinter Meeting in Philadelphia. Beth Ebenstein Mulch of Alexandria, VA, and Jillian Rudes of Brooklyn, NY, will participate in project planning workgroups; network with peers; gain an inside look into ALA structure; and have an opportunity to serve the profession in a leadership capacity early in their careers. PLA’s primary responsibility in the Edge Initiative was to develop a training curriculum that soft launched in the summer and was completed this fall. The training consisted of four courses that demonstrated how to use the benchmarks beyond measurement: Community Assessment, Advocacy, Technology Management, and Library Leadership. Each course was delivered multiple times via online facilitated webinar over a five week period in August and September. In total, 314 training seats were filled by 141 unique attendees. Preliminary training results were collected and overall, 80% of Edge training participants were either completely satisfied or mostly satisfied with the training.
