### 2016 ALA Annual Conference & Exhibition—Libraries Transform, and We Stand With Orlando

With an emphasis on the future of libraries, on diversity, equity, and inclusion, and on library transformation driven by community aspirations, 16,597 librarians, library workers and library supporters (including 4,995 exhibitors) attended the [2016 ALA Annual Conference & Exhibition](#) in Orlando, Florida, June 23 – 28. The conference marked ALA's 140th anniversary. A memorial event for the Pulse nightclub shooting victims was joined by Congressman John Lewis, one of the many speakers who moved and inspired conference attendees. From the more than 2,500 planned continuing education programs, workshops, and preconferences to peer-to-peer sessions and chance encounters in intentionally informal meeting spaces—such as the Networking Uncommons and ALA Lounge—attendees exchanged and discussed ideas, updates, and innovations. ### Library Card Sign-up Month (September)

The Public Awareness Office (PAO) is working closely with Peanuts to develop multiple promotions centered around Snoopy as the honorary spokesdog for the Library Card Sign-up Month, including a Facebook profile frame that will be debuted in September to drive traffic and awareness for the month of events. Additional efforts include a potential partnership with Overdrive that will feature downloadable lists of ebooks to correspond with events happening in September, including Hispanic Heritage Month and Banned Books Week. PAO is currently working on Library Card Sign-up Month publicity efforts as well. Deliverables include a [web press kit](#), audio [PSAs](#) and press releases in both [English](#) and [Spanish](#). Efforts to secure placements with mainstream and library trade media are in full swing. Thus far PAO has secured PSA placements with WESB News Radio 1490 AM, Bradford, Pennsylvania; and WCPT 820 AM & 92.5 FM, serving Chicago, Illinois. PAO also has reached out to Westwood One and more than 40 regional news talk radio networks to secure PSAs. PAO secured a Spanish Language Library Card Sign-up Month interview with [El Sol 103.9 FM y 980](#) in Charleston, South Carolina. PAO provided graphics and talking points to Charleston County Public Library, and their team provided a Spanish speaking spokesperson to participate in the interview.

## Libraries Transform

As of August 19, more than 3,500 libraries and supporters have joined ALA's Libraries Transform campaign. At ALA's Annual Conference in Orlando, the campaign was front and center, represented in the opening session, *Cognotes*, as well as through signage and collateral throughout the convention center. New *Because* statements, developed by Little Jacket, to support President Todaro's initiative were unveiled at the conference and are available online at [librariestransform.org](http://librariestransform.org). PAO Director Jeff Julian and Office for Library Advocacy (OLA) Director Marci Merola presented a session at the conference, *Libraries Transform: Tools and Training*, which featured a panel of representatives from libraries using the campaign successfully. Additional presentations on the campaign were given at the Chapter Relations Committee meeting as well as at the Public Awareness Committee meeting. In July, PAO Director Jeff Julian presented on the Libraries Transform campaign at a conference hosted by SWAN, (System Wide Automated Network), a membership organization for libraries in the Chicago area. ## New Librarian of Congress

The Senate approved the nomination of Dr. Carla Hayden to serve as the nation's 14th Librarian of Congress. Dr. Hayden is a past president of the American Library Association and director of the Enoch Pratt Free Library in Baltimore, Maryland. She is the first female and the first African American to lead the Library of Congress. She also is the first professional librarian to be confirmed in more than 60 years. The PAO worked with ALA President Julie Todaro to craft a [statement](#) that highlighted Dr. Hayden's professional competencies and visionary leadership. The statement was distributed to library trade, book, education, feature and political editors and was picked up by [American Libraries](#), [Publishers Weekly](#), [USA Today](#), [Roll Call](#), [Smithsonian](#), [Washington Post](#). *USA Today* coverage was distributed over its national wire and picked up by more than [800 news websites](#). The ALA also was mentioned in [The Atlantic](#), [TIME](#), [ESSANCE](#), [Slate](#) coverage.

## AASL Defines 'effective school library program' for ESSA Implementation

As the national association for the school library profession, AASL has defined the term "effective school library program" to assist with the implementation of the Every Student Succeeds Act (ESSA) at the state and district level: "An effective school library program has a certified school librarian at the helm, provides personalized learning environments, and offers equitable access to resources to ensure a well-rounded education for every student." Honoring the work of ALCTS in sustaining the past and establishing a solid foundation for the future of technical services, collection management, and preservation, the new slogan, *Creating the Future, Preserving the Past*, will be used to promote the association and its mission and goals. Part of the celebration of the 60th Anniversary of ALCTS in 2017, the ALCTS Slogan Contest ran from April 25-May 6, 2016. More than 50 entries were submitted and ALCTS members were invited to participate in two rounds of voting. The ALCTS Office and the ALCTS Advocacy and Policy Committee thank all who took part in this exciting contest.

### **Membership Development**

#### Membership Statistics

At the end of July 2016, total ALA membership was 57,265. This is 2,800 greater than July of 2015. Four divisions: ALSC, ASCLA, PLA, and United for Libraries had membership growth. Seven round tables: EMIERT, GAMERT, GLBTRT, LearnRT, RMRT, SRRT, and SustainRT had increased membership compared to last year. Small and very small library organizational memberships have re-bounded, and there is growth in the medium and large library categories. The combined total of corporate/champion members has increased to 178 compared to 172 in 2015.

### **Office for Intellectual Freedom (OIF)**

#### Office for Intellectual Freedom's New Program Officer.

On August 1, Eleanor (Ellie) Diaz joined the Office for Intellectual Freedom as its new program officer. Ellie describes herself as a "creative journalist specializing in literary and nonprofit beats." She has been a communications intern for ALA since Fall of 2015, and a copy editor and columnist before that. Ellie graduated magna cum laude from Loyola University, where she studied English and Journalism. She has a passion for social justice, and is eager to be working, as did Nanette Perez before her, on Banned Books Week, as well as committee support and social media.

#### "Our Voices" Initiative

Shumeca Pickett has left the Office for Intellectual Freedom, but continues to head up OIF's Chicago-focused "Our Voices" advisory committee as an independent contractor. Jamie LaRue will be presenting more details about the "Our Voices" initiative at future Unit Manager meetings. The initiative is designed to respond to factors such as the preponderance of diverse authors and books with diverse content on the most-challenged book lists and the dominance of non-diverse decision makers and content within mainstream publishing.

## 2016 IFLA Conference Presentations

OIF Director Jamie LaRue presented twice at the 2016 IFLA conference in Columbus, Ohio. The first presentation was on creating a library privacy policy, and the second on OIF's Banned Books Week program. Both sessions were very well received.

### ALA Annual Conference & Exhibition (June 23 – 28)

The Public Awareness Office (PAO) worked closely with ALA leadership, divisions and offices to secure media coverage of the 2016 ALA Annual Conference and Exhibition in Orlando. The PAO developed a media [press kit](#), local press lists, event remarks and [statements](#) regarding the conference memorial and diversity activities. More than 60 mainstream and trade press members registered for media credentials. Attending media included CNN.com, WKMG (Orlando CBS Affiliate), [Orlando Sentinel](#), [Orlando Weekly](#), Orlando Business TV and online radio station Latino 247. In addition, PAO developed and distributed press materials to more than 200 library trade and Orlando media targets. Media groups were interested in securing sources to discuss the transforming role of libraries, community engagement, diversity, advocacy, ebooks, privacy and other conference-related issues. Multiple media interviews with ALA leadership took place during the Annual Conference. For example, Orlando news radio station WDBO spoke with President Sari Feldman about the ALA memorial for the Pulse nightclub shooting victims and other conference topics. Local NPR affiliate WMFE interviewed Feldman for a story about library programs that support STEM education for young people and other educational and technology opportunities available through libraries. Coverage highlights of the ALA Annual Conference & Exhibition include articles from [American Libraries](#), [Christian Science Monitor](#), [Publishers Weekly](#), [Library Journal](#), [Newsarama](#), and a mention from Closing Session Keynote Speaker Jamie Lee Curtis within a [Huffington Post](#) blog post. PAO also assisted BCALA with coverage of its Reading is Grand initiative within the event's onsite daily *Cognotes*. Additionally, PAO partnered with the Public Awareness Committee to present the PR Forum, which featured speaker Debra Fine, author of *The Fine Art of Small Talk*, who addressed a packed room with a presentation on building relationships at the library.
