Selected Bibliography of US Government and International Documents on Latin America and the Caribbean

U.S. government and international documents are valuable information resources for Area/International Studies classes. The interdisciplinary nature of information, coverage of political and global issues, and free online availability of documents is invaluable for scholarly research. Particularly, Latin America and Caribbean is of geopolitical importance to the United States. Hence, this bibliography on Latin American Caribbean government resources has been compiled to help faculty, students, and independent scholars specializing in Latin American Studies, Global Studies, International Business/Trade, etc. It would also be useful for new U.S. Government/ International Documents Librarians as well as Latin American and Caribbean Studies Librarians in teaching research consultations and library instruction sessions. This bibliography mainly concentrates on freely available online resources. They have been selected based on the credibility of the information provider, in-depth coverage of national/international issues and historical and contemporary information, availability of datasets and statistics, clear organization of information, and their significance for Area /International/ Latin American and Caribbean Studies.

The bibliography has been divided into five sections – a) United States government resources, b) government websites of Latin American and Caribbean countries, c) data, statistics, and statistical resources from Latin American and Caribbean government resources, d) international, intergovernmental organizations, and non-governmental organizations, and e) libraries and academic resources. The focus of the first section is U.S. government resources available from several government information websites. The second section lists the government websites of the various Latin American and Caribbean countries. The third section comprises data and statistical resources from the Latin American and Caribbean Government Agencies. Section four lists IGO/NGO resources for Latin American and Caribbean countries. The last section concentrates on libraries and academic institution resources on Latin America and the Caribbean.
