Bill Marden, chair of the program committee, presented on his proposed program for Annual Conference in New Orleans. Marden asked for \$700.00 to bring in speaker, Paul Rosenzweig, an expert on privacy and big data. James moved approve the expense. Huffaker seconded. The motion passed.

Cyndi Robinson, chair of the bylaws and organization committee, reported that the committee has been working on a handbook for future IFRT leaders.

Wanda Mae Huffaker, chair of the membership committee, reported that membership numbers are up. Kristin Pekoll commended the committee for reaching out to new members and renewing members.

Eric Johnson reported on the publications committee. Stephanie Barnaby and Keith Weimer have been working on social media for IFRT. There was some discussion surrounding ways IFRT could utilize social media.

Larissa Gordon reported on the coalition building committee. Kristin Pekoll reported that the committee is doing a great job building coalitions with the state Intellectual Freedom committees and keeping her informed.

Michael Furlong reported that the Immroth Award had five nominations as of Dec. 1

Laura Kolututsky, chair of the Oboler committee, reported that the call for nominations was extended to Dec. 15. As of the meeting, there were 6 nominations.

IFRT Councilor, Martin Garnar, reported no resolutions had been introduced as of this meeting, but as Midwinter Meeting draws closer that is likely to change. Garnar discussed a petition circulating among ALA members that attempts to put a measure on the ALA spring ballot in an effort to overturn the most recent decision by ALA Council to change the language of the job announcement for the next ALA Executive Director from MLIS preferred back to MLIS required. Mary Ghikas will continue to serve as executive director until the search can move forward after the election ends on April 11.

Report from Jamie La Rue- in 2018, OIF will have 10 more advocacy boot camps around the country. OIF will also be developing a boot camp regarding Law and Libraries including first amendment law, copyright, and liability.

IFRT will meet on Sunday, Feb. 11 at 3- 5 p.m. in Colorado Convention Center Room 301. Kristin has added a calendar with all IF related meetings on ALA Connect.

Motion to approve the expenses of \$3,000.00 for a speaker for the IFRT fundraiser. At Annual Conference, IFRT will host a fundraising breakfast with a speaker TBD.

Cyndi Robinson seconded.

Motion passed.

Chairperson Kratz asked for any other business, and as there was none, Huffaker moved to adjourn the meeting.

Garnar seconded the motion.
