- POLICY STATEMENT TASK FORCE

Function Statement:

To develop a draft policy statement on the value of public library services for children. Such a statement should address the need for children's services in public libraries, how to articulate those needs and how to promote these services.

To present the draft policy statement to both the ALSC and PLA Board of Directors for endorsement by Annual Conference 1994.

Special Note: This special committee will be expected to develop a process which fosters active participation from the membership of both ALSC and PLA. The committee is encouraged to conduct at least one open hearing to provide an opportunity for membership discussion on the topic and/or the draft policy statement.

Established: 1993 Midwinter Meeting

3 members of PLA, one of whom shall be a liaison from the Public Policy for Public Libraries section
Chair to be a joint appointment by the appointing authorities of both divisions
